IN THE MATTER OF:

Discussion and Possible Decision regarding the temporary allocation of medallions for the NASCAR race from Friday, March 8, 2013 through Sunday, March 10, 2013.

ORDER

At a regular monthly session of the State of Nevada Taxicab Authority Board, held at the Nevada Taxicab Authority, 1785 E. Sahara Ave., Ste. 200, Las Vegas, NV 89104.

The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

1. On February 26, 2013, a public hearing was held regarding the above-entitled matter (the "Event"), in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties appeared and were permitted to be heard.
2. The Taxicab Authority is authorized to allocate temporary additional medallions, pursuant to NRS 706.88245, whenever circumstances require a temporary increase in the number of taxicabs allocated, pursuant to NRS 706.8824.
3. The Event is the NASCAR race held at the Las Vegas Speedway from Friday, March 8, 2013 through Sunday, March 10, 2013.

1 4. The following filed Petitions to Intervene and all were permitted to intervene and be  
2 heard: (1) Nellis Cab Company, (2) Yellow/Checker/Star Cab Companies, (3)  
3 Whittlesea Blue/Henderson Taxi, (4) Ace Cab, Inc., Union Cab Co., A NLV Cab Co.,  
4 Vegas-Western Cab Co. and Virgin Valley Cab Company, Inc., (5) A Cab, LLC, (6)  
5 Desert Cab Company, (7) Lucky Cab Company, (8) Western Cab Company, (9) ITPE  
6 Union.

7 5. Intervenors were allowed to present arguments and evidence regarding the nature of  
8 the event, the expected attendance of the event and the nature of the attendees of the  
9 event.

10 6. Based upon the arguments, evidence and recommendations submitted by Intervenors,  
11 the Board finds that there is no need for temporary, additional taxicabs to service the  
12 public for the Event, and accordingly, the Board finds there should not be an allocation  
13 of temporary medallions.

15 THEREFORE, IT IS HEREBY ORDERED that the Administrator shall not issue  
16 temporary additional medallions for the above-referenced event.
