The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

1. On January 28, 2014, a public hearing was held regarding the above-entitled matter (the "Event"), in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties appeared and were permitted to be heard.
2. The Taxicab Authority is authorized to allocate temporary additional medallions, pursuant to NRS 706.88245, whenever circumstances require a temporary increase in the number of taxicabs allocated, pursuant to NRS 706.8824.

- 1 3. The Event is the 2014 NAHB's International Builders' Show and the Kitchen & Bath
2 Industry Show, which will run simultaneously at the LVCVA from February 4, 2014
3 through February 6, 2014, with an expected attendance of 75,000.
- 4 4. The following filed Petitions to Intervene and all were permitted to intervene and be
5 heard: (1) Desert Cab Company, (2) Western Cab Company, (3) A Cab LLC, (4) Nellis
6 Cab Company, (5) Yellow/Checker/Star Cab Companies, (6) Whittlesea Blue Cab
7 Company/Henderson Taxi, (7) Lucky Cab Company, (8) Ace Cab, Inc., Union Cab Co.,
8 A NLV Cab Co., Vegas-Western Cab, Inc., and Virgin Valley Cab Company, and (9)
9 ITPE Union.
- 10 5. Intervenors and Staff were allowed to present argument and evidence regarding the
11 nature of the event, the expected attendance of the event and the nature of the
12 attendees of the event.
- 13 6. Based upon the arguments, evidence and recommendations submitted by Intervenors
14 and Staff, the Board finds that there is a need for temporary, additional taxicabs to
15 service the public at the Event, which the Board, accordingly, finds should be
16 addressed by a temporary allocation of additional medallions.
- 17 7. Pursuant to NRS 706.88245(2), any temporary allocation of additional medallions must
18 be apportioned equally among the certificate holders in the area to be affected by the
19 allocation.

22 THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary
23 additional medallions to address the need for additional taxicabs for the above-referenced
24 event, as follows:

26 4 medallions per company

27 7:00 AM to 7:00 PM

TUESDAY, FEBRUARY 4, 2014

4 medallions per company
7:00 AM to 7:00 PM
and
4 medallions per company
12:00 PM to 2:00 AM
(any 12-hour period)

WEDNESDAY, FEBRUARY 5, 2014

4 medallions per company
7:00 AM to 7:00 PM
and
4 medallions per company
12:00 PM to 2:00 AM
(any 12-hour period)

THURSDAY, FEBRUARY 6, 2014

4 medallions per company
7:00 AM to 7:00 PM

IT IS FURTHER ORDERED that the authorized additional cabs may be put into service only during the times and dates set forth herein.
