The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

1. On July 29, 2014, a public hearing was held regarding the above-entitled matter (the "Event"), in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties appeared and were permitted to be heard.
2. The Taxicab Authority is authorized to allocate temporary additional medallions, pursuant to NRS 706.88245, whenever circumstances require a temporary increase in the number of taxicabs allocated, pursuant to NRS 706.8824.

- 1 3. The Event is the 2014 Laughlin River Regatta, held in Laughlin, Nevada, from August
2 8, 2014 through August 10, 2014.
- 3 4. The following filed Petitions to Intervene and all were permitted to intervene and be
4 heard: (1) Lucky Cab Company, and (2) Western Cab Company.
- 5 5. Intervenors and Staff were allowed to present argument and evidence regarding the
6 nature of the event, the expected attendance of the event and the nature of the
7 attendees of the event.
- 8 6. Based upon the arguments, evidence and recommendations submitted by Intervenors
9 and Staff, the Board finds that there is a need for temporary, additional taxicabs to
10 service the public at the Event, which the Board, accordingly, finds should be
11 addressed by a temporary allocation of additional medallions.
- 12 7. Pursuant to NRS 706.88245(2), any temporary allocation of additional medallions must
13 be apportioned equally among the certificate holders in the area to be affected by the
14 allocation.

16 THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary
17 additional medallions to address the need for additional taxicabs for the above-referenced
18 event, as follows:

20 **FRIDAY, AUGUST 8, 2014 at 12:00 p.m.**

22 **MONDAY, AUGUST 11, 2014 at 12:00 p.m.**
23 2 medallions per company – Lucky Cab Company and Desert Cab Company only
