DISCUSSION AND POSSIBLE DECISION REGARDING THE SEARCH FOR THE TAXICAB AUTHORITY ADMINISTRATOR POSITION

ORDER

At a regular monthly session of the State of Nevada Taxicab Authority Board, held at the Nevada Taxicab Authority, 2080 E. Flamingo Road, Suite 114, Las Vegas, NV 89119.

The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

1. On October 20, 2014, a public hearing was held regarding the above-entitled matter in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties appeared and were permitted to be heard.
2. Pursuant to NRS 706.882, the Director of the Department of Business and Industry shall appoint a Taxicab Administrator from a list of three names submitted to the Director by the Taxicab Authority. The Administrator serves at the pleasure of the Director. The Administrator is in the unclassified service of the State.
3. Western Cab Company filed a Petition to Intervene and was permitted to intervene and be heard.

1 THEREFORE, IT IS HEREBY ORDERED that the Department of Administration,
2 Human Resource Management, shall conduct the recruitment to fill the position of
3 Administrator, as follows: 1) draft the position announcement and solicit resumes, 2) review
4 resumes for minimum qualifications set forth in the position announcement, 3) compile
5 resumes of individuals who meet the minimum qualifications in books for the Taxicab
6 Authority Board, 4) distribute or send resume books directly to the Taxicab Authority Board
7 members, 5) the Taxicab Authority Board will have thirty (30) days to review the resumes prior
8 to the open meeting where they will be discussed, 6) the Taxicab Authority Board will conduct
9 interviews in accordance with the Open Meeting Law.

11 IT IS FURTHER ORDERED that the minimum qualifications for the position of
12 Administrator shall be as follows: 1) Bachelor's Degree in Business Administration (or related
13 field) from an accredited university, 2) minimum of five (5) years of management experience
14 related to the transportation industry, 3) experience with governmental agencies, 4) live or
15 work for three or more years in a county with more than 500,000 residents and 5) familiarity
16 with transportation technology systems (desired).

18 IT IS FURTHER ORDERED that the announcement of the vacant position of
19 Administrator shall be posted in the following locations: 1) International Association of
20 Transportation Regulators (IATR), 2) Taxicab, Limousine, and Paratransit Association
21 (TLPA), 3) Review Journal, 4) Los Angeles Times and 5) the usual posting places for such
22 announcements.
