**ORDER**

The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

FINDINGS OF FACT

1. On October 20, 2014, a public hearing was held in the above-entitled matter, in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, and Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC).
2. At this duly noticed meeting, Agenda Item No. 9 was listed as captioned above.
3. The Applicant, Newton Howard Dudley, seeks authorization from the Taxicab Authority Board to transfer his entire interest (10 voting shares and 990 non-voting shares) in

1 Taxicab Operating Rights CPCT 399, CPCT 712 and CPCT 439 to the Dudley 2012  
2 Family Trust and to act as Trustee.

- 3 4. Nevada Yellow Cab Corporation (CPCT 439), Nevada Checker Cab Corporation  
4 (CPCT 712), and Nevada Star Cab Corporation (CPCT 399) each hold a Certificate of  
5 Public Convenience and Necessity issued by the Taxicab Authority.  
6 5. There was no opposition from any interveners.

7 CONCLUSIONS OF LAW

- 8 6. Pursuant to NAC 706.465, no transfer of shares in a company holding a Certificate of  
9 Public Convenience and Necessity can take place without the prior approval of the  
10 Taxicab Authority.  
11 7. Pursuant to NAC 706.453, the Taxicab Authority reserves the right to conduct a  
12 background investigation to determine an applicant's suitability to hold an interest in a  
13 company holding a Certificate of Public Convenience and Necessity.  
14 8. Based on the background investigation conducted by the Chief of Enforcement,  
15 Newton Howard Dudley meets the requirements to hold an interest in a company  
16 holding a Certificate of Public Convenience and Necessity.  
17 9. The Taxicab Authority finds that the Applicants' request, outlined above, is appropriate  
18 under NAC 706.465 and .453.



22 IT IS HEREBY ORDERED that pursuant to NAC 706.465 and .453, the Application of  
23 Sherry Ann Dudley to act as the Trustee of the Dudley 2012 Family Trust, which upon  
24 approval of the Taxicab Authority, will hold Newton Howard Dudley's shares of Nevada Yellow  
25 Cab Corporation, Nevada Checker Cab Corporation, and Nevada Star Cab Corporation, is  
26 approved.

2 Trust apply for approval.
