DISCUSSION AND POSSIBLE DECISION REGARDING THE APPLICATION OF SHERRY ANN DUDLEY, SEEKING APPROVAL TO ACT AS TRUSTEE OF THE DUDLEY 2012 FAMILY TRUST, WHICH UPON APPROVAL OF THE TAXICAB AUTHORITY, WILL HOLD NEWTON HOWARD DUDLEY'S SHARES OF NEVADA YELLOW CAB CORPORATION, NEVADA CHECKER CAB CORPORATION AND NEVADA STAR CAB CORPORATION, WHICH ALREADY HOLD CPCN'S ISSUED BY THE TAXICAB AUTHORITY

The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

FINDINGS OF FACT

1. On October 20, 2014, a public hearing was held in the above-entitled matter, in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, and Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC).
2. At this duly noticed meeting, Agenda Item No. 10 was listed as captioned above.

- 1 3. The Applicant, Sherry Ann Dudley, seeks authorization from the Taxicab Authority  
2 Board to potentially act as Trustee of the Dudley 2012 Family Trust, which upon  
3 approval of the Taxicab Authority, will hold Newton Howard Dudley's shares of Nevada  
4 Yellow Cab Corporation, Nevada Checker Cab Corporation, and Nevada Star cab  
5 Corporation.
- 6 4. Nevada Yellow Cab Corporation, Nevada Checker Cab Corporation, and Nevada Star  
7 Cab Corporation each hold a Certificate of Public Convenience and Necessity issued  
8 by the Taxicab Authority.
- 9 5. There was no opposition from any interveners.

11 CONCLUSIONS OF LAW

- 12 6. Pursuant to NAC 706.465, no transfer of shares in a company holding a Certificate of  
13 Public Convenience and Necessity can take place without the prior approval of the  
14 Taxicab Authority.
- 15 7. Pursuant to NAC 706.453, the Taxicab Authority reserves the right to conduct a  
16 background investigation to determine an applicant's suitability to hold an interest in a  
17 company holding a Certificate of Public Convenience and Necessity.
- 18 8. Based on the background investigation conducted by the Chief of Enforcement, Sherry  
19 Ann Dudley meets the requirements to hold an interest in a company holding a  
20 Certificate of Public Convenience and Necessity.
- 21 9. The Taxicab Authority finds that the Applicants' request, outlined above, is appropriate  
22 under NAC 706.465 and .453.

4 of the Taxicab Authority, will hold Newton Howard Dudley's shares of Nevada Yellow Cab  
5 Corporation, Nevada Checker Cab Corporation, and Nevada Star cab Corporation, is  
6 approved:

7 IT IS FURTHER ORDERED that the successor trustees for the Dudley 2012 Family  
8 Trust apply for approval.
