**ORDER**

The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

FINDINGS OF FACT

1. On January 29, 2015, a public hearing was held regarding the above-entitled matter (the "Event"), in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties appeared and were permitted to be heard.

- 1 2. The Taxicab Authority is authorized to allocate temporary additional medallions,  
2 pursuant to NRS 706.88245, whenever circumstances require a temporary increase in  
3 the number of taxicabs allocated, pursuant to NRS 706.8824.
- 4 3. The Event is the 2015 M.A.G.I.C. Convention, held at the LVCVA and the Mandalay  
5 Bay Convention Center, with an estimated attendance of 83,000.
- 6 4. The following filed Petitions to Intervene and all were permitted to intervene and be  
7 heard: (1) Desert Cab Company, (2) Western Cab Company, (3) A Cab LLC, (4) Nellis  
8 Cab Company, (5) Yellow/Checker/Star Cab Companies, (6) Whittlesea Blue Cab  
9 Company/Henderson Taxi, (7) Lucky Cab Company, (8) Ace Cab, Inc., Union Cab Co.,  
10 A NLV Cab Co., Vegas-Western Cab, Inc., and Virgin Valley Cab Company, (9) Deluxe  
11 Cab Company and (10) ITPE Union.
- 12 5. Intervenors and Staff were allowed to present argument and evidence regarding the  
13 nature of the event, the expected attendance of the event and the nature of the  
14 attendees of the event.

#### 15 CONCLUSIONS OF LAW

- 16 1. Based upon the arguments, evidence and recommendations submitted by Intervenors  
17 and Staff, the Board concludes that there is a need for temporary, additional taxicabs  
18 to service the public at the Event, which the Board, accordingly, finds should be  
19 addressed by a temporary allocation of additional medallions.
- 20 2. Pursuant to NRS 706.88245(2), any temporary allocation of additional medallions must  
21 be apportioned equally among the certificate holders in the area to be affected by the  
22 allocation.

1            THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary  
2 additional medallions to address the need for additional taxicabs for the above-referenced  
3 event, as follows:

4    **MONDAY, FEBRUARY 16, 2015**

5    3 medallions per company  
6    12:00 PM to 2:00 AM  
    (any 12-hour period)

7    **TUESDAY, FEBRUARY 17, 2014 and WEDNESDAY, FEBRUARY 18, 2014**

8    3 medallions per company  
9    7:00 AM to 7:00 PM  
    and

10     3 medallions per company  
    12:00 PM to 2:00 AM  
    (any 12-hour period)


11     **THURSDAY, FEBRUARY 19, 2014**

12     3 medallions per company  
13     7:00 AM to 7:00 PM

14            IT IS FURTHER ORDERED that the authorized additional cabs may be put into service  
15 only during the times and dates set forth herein.
