The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

FINDINGS OF FACT

1. On February 26, 2014, a public hearing was held regarding the above-entitled matter (the "Event"), in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties appeared and were permitted to be heard.
2. The Taxicab Authority is authorized to allocate temporary additional medallions, pursuant to NRS 706.88245, whenever circumstances require a temporary increase in the number of taxicabs allocated, pursuant to NRS 706.8824.

- 1 3. The following filed Petitions to Intervene and all were permitted to intervene and be
2 heard: (1) Desert Cab Company, (2) Nellis Cab Company, (3) ITPE Union, (4)
3 Whittlesea Blue/Henderson Taxi, (5) Yellow/Checker/Star Cab Companies, (6)
4 Western Cab Company, (7) Lucky Cab Company, (8) Deluxe Cab Company, (9) Ace
5 Cab, Inc., Union Cab Co., A NLV Cab Co., Vegas-Western Cab Co. and Virgin Valley
6 Cab Company, Inc., and (10) A Cab, LLC.
- 7 4. Intervenors and Staff were allowed to present argument and evidence regarding the
8 nature of the event, the expected attendance of the event and the nature of the
9 attendees of the event.

11 CONCLUSIONS OF LAW

- 12 1. Based upon the arguments, evidence and recommendations submitted by Intervenors
13 and Staff, the Board finds that there is a need for temporary, additional taxicabs to
14 service the public at the Events, which the Board, accordingly, finds should be
15 addressed by a temporary allocation of additional medallions.
- 16 2. Pursuant to NRS 706.88245(2), any temporary allocation of additional medallions must
17 be apportioned equally among the certificate holders in the area to be affected by the
18 allocation.

20 ORDER

21 THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary
22 additional medallions to address the need for additional taxicabs for the above-referenced
23 event, as follows:

24 **MONDAY, APRIL 13, 2015**

25 5 medallions per company
26 12:00 PM to 2:00 AM
27 (any 12-hour period)

1 TUESDAY, APRIL 14, 2015
2 and
3 WEDNESDAY, APRIL 15, 2015

4 5 medallions per company
5 7:00 AM to 7:00 PM

6 and
7 5 medallions per company
8 12:00 PM to 2:00 AM
9 (any 12-hour period)

10 THURSDAY, APRIL 16, 2015

11 5 medallions per company
12 7:00 AM to 7:00 PM

13 IT IS FURTHER ORDERED that the authorized additional cabs may be put into service
14 only during the times and dates set forth herein.
