The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

FINDINGS OF FACT

1. On April 7, 2015, a public hearing was held in the above-entitled matter in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, and Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time at which time all interested parties appeared and were permitted to be heard.
2. The following filed Petitions to Intervene and all were permitted to intervene and be heard: (1) Desert Cab Company, (2) Nellis Cab Company, (3) ITPE Union, (4) Whittlesea Blue/Henderson Taxi, (5) Western Cab Company, (6) Lucky Cab

1 Company, (7) Deluxe Cab Company, (8) Ace Cab, Inc., Union Cab Co., A NLV Cab
2 Co., Vegas-Western Cab Co. and Virgin Valley Cab Company, Inc., (9) A Cab, LLC.,
3 and (10) Yellow Checker Star Cab Companies.

- 4 3. Deluxe /Boulder Cab Company provided testimony regarding their understanding that
5 Deluxe Cab was authorized to pick up at McCarren Airport as authorized in a Board
6 Order expanding Deluxe/Boulder's northern geographical boundary from Sunset Road to
7 Russell Road.
- 8 4. Deluxe Cab further testified that those medallions which are restricted to pick up in
9 Deluxe/ Boulder's limited area as stated in the Board's Order expanding their Northern
10 boundary from Sunset Road to Russell Road included service to those properties that
11 abut the north side of Russell Road which geographically includes McCarren Airport.
- 12 5. Intervenors were allowed to present argument and evidence. Industry Intervenors
13 established that Deluxe/Boulder's industry agreement never included the expansion for
14 Deluxe/Boulder to pick up at McCarren Airport. A corresponding email was presented
15 by Mark Trafton, Esq., of Whittlesea Bell, as evidence to confirm that McCarren Airport
16 was never included in the agreement between Deluxe/Boulder and the industry.

20 CONCLUSIONS OF LAW

- 21 1. Based upon the arguments, evidence and recommendations submitted by interveners
22 and Mark Trafton Esq., the Board concluded and clarified that Deluxe/Boulder Cab
23 Company geographical expanded medallions are not authorized to pick up at
24 McCarran Airport.
