The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

1. On April 30, 2015, a public hearing was held regarding the above-entitled matter (the "Event"), in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties appeared and were permitted to be heard.
2. The Taxicab Authority is authorized to allocate temporary additional medallions, pursuant to NRS 706.88245, whenever circumstances require a temporary increase in the number of taxicabs allocated, pursuant to NRS 706.8824.
3. The Event is the Floyd Mayweather vs Manny Pacquiao prize fight on May 2nd, 2015.

- 1 4. The following filed Petitions to Intervene and all were permitted to intervene and be
2 heard: (1) Lucky Cab Company, (2) Western Cab Company, and (3) A Cab Company,
3 (4) Nellis Cab Company, (5) Yellow/Checker/Star Cab Companies, (6) Desert Cab
4 Company, (7) Whittlesea Blue/Henderson Taxi, (8) Ace Cab, Inc., Union Cab Co., A
5 NLV Cab Co., Vegas Western Cab, Inc., and Virgin Valley Cab Company, Inc., (9)
6 ITPE Union.
- 7 5. Intervenors and Staff were allowed to present argument and evidence regarding the
8 nature of the event, the expected attendance of the event and the nature of the
9 attendees of the event.

11 CONCLUSIONS OF LAW

- 12 1. Based upon the arguments, evidence and recommendations submitted by Intervenors
13 and Staff, the Board finds that there is a need for temporary, additional taxicabs to
14 service the public at the Event, which the Board, accordingly, finds should be
15 addressed by a temporary allocation of additional medallions.
- 16 2. Pursuant to NRS 706.88245(2), any temporary allocation of additional medallions must
17 be apportioned equally among the certificate holders in the area to be affected by the
18 allocation.

21 THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary
22 additional medallions to address the need for additional taxicabs for the above-referenced
23 event, as follows:

10 Medallions per company
11 AM - 4 AM (any 12 hours)

10 5 medallions per company

12 PM - 2 AM (any 12 hours)


