



A Petition to Intervene must contain the number of the Agenda Item for which permission to intervene is being sought. Further, the Petition ***must contain a clear and concise statement of the position to be taken on the item as well as a brief description of any evidence to be presented.***

PLEASE TAKE FURTHER NOTICE that a *Petition which does not specify the Agenda Item for which leave to intervene is sought and/or does not state clearly and concisely, the position the Intervener will take on the specific agenda item, will be deemed insufficient and permission to intervene will be denied.*
