23 The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact
24 and conclusions of law.

25 1. On the 26th day of January, 2010, a public hearing was held regarding the
26 above-entitled matters (the "Events"), in compliance with the provisions of the Nevada Open
27 Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised
28 Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested
parties appeared and were heard.

1. The Taxicab Authority is authorized to allocate temporary additional medallions,
pursuant to NRS 706.8824 and 706.88245, whenever circumstances require a temporary
increase in the number of taxicabs allocated.

3. Staff recommended allocation of temporary, special-event medallions for the

1 above-referenced events, based upon the estimated attendance, and the nature of the
2 attendees and the events. Staff recommended an allocation of 5 additional medallions per
3 company on Sunday, January 31, 2010 from 7:00 A.M.-7:00 P.M. and 5 additional medallions
4 from 12:00 P.M.- 12:00 A.M; 10 additional medallions per company on Monday, February 1,
5 2010 from 7:00 A.M.-7:00 P.M. and 10 additional medallions from 12:00 P.M.- 12:00 A.M; 15
6 additional medallions per company on Tuesday, February 2, 2010 from 7:00 A.M.-7:00 P.M.
7 and 15 additional medallions from 12:00 P.M.- 12:00 A.M; 15 additional medallions per
8 company on Wednesday, February 3, 2010 from 7:00 A.M.-7:00 P.M. and 15 additional
9 medallions from 12:00 P.M.- 12:00 A.M; 15 additional medallions per company on Thursday,
10 February 4, 2010 from 7:00 A.M.-7:00 P.M. and 15 additional medallions from 12:00 P.M.-
11 12:00 A.M; and 15 medallions on Friday, February 5, 2010 from 7:00 A.M. to 7:00 P.M. Staff
12 amended its recommendations during the hearing to change “12:00 A.M.” to “2:00 A.M.” for
13 all above-listed timeframes.

14 4. The following filed Petitions to Intervene and all were permitted to intervene and
15 be heard: (1) Lucky Cab Company, (2) Desert Cab Company, (3) Western Cab Company, (4)
16 Frias Holding Company, (5) Nellis Cab Company, (6) Yellow/Checker/Star Cab Companies,
17 (7) A Cab, LLC, (8) Whittlesea Blue/Henderson Taxi, (9) United Steelworkers Union and (10)
18 ITPE Union. No representative from Nellis Cab Company was present at the hearing.

19 5. Based upon staff’s recommendations, as well as the testimony and
20 recommendations of the Intervenors, the Board finds that there is a need for temporary,
21 additional taxicabs to service the public at the Events, which the Board, accordingly, finds
22 should be addressed by a temporary allocation of additional medallions.

23 6. Pursuant to NRS 706.88245(2), the Board is required to allocate the temporary
24 increase in medallions equally among the certificate holders. All companies, except those
25 specifically prohibited by their certificates, are entitled to share in the temporary additional
26 allocation, which temporary additional medallions are only to be used in each company’s
27 certificated area.

7 the Board, to remove medallions in proportion to any shortfall, if attendance falls short of
8 expected attendance.
