17	The TAXICAB AUTHORITY makes the following findings of fact and conclusions of law:
18	1. On the 26 th day of January, 2010, a public hearing was held in the above-entitled
19	matter, in compliance with the provisions of the Nevada Open Meeting Law, the Nevada
20	Administrative Procedure Act, and Chapter 706 of the Nevada Revised Statutes (NRS) and the
21	Nevada Administrative Code (NAC).
22	2. At this duly noticed meeting, Agenda Item No. 10 was listed as captioned above.
23	3. The Applicant, LARRY E. BELL, SR., seeks authorization from the Taxicab
24	Authority board to transfer four (4) voting shares and 196 non-voting shares of Henderson Taxi,
25	a Nevada corporation to The Larry E. Bell Separate Property Trust, dated June 10, 2009 ("the
26	Trust"). Henderson Taxi currently holds a Certificate of Public Convenience and Necessity

1	issued by the Taxicab Authority. Applicant also seeks an order to approve the appointment of
2	Larry E. Bell, Jr. and Kathleen Jo Kusler as successor trustees of the Trust.
3	4. No parties have sought leave to intervene in this application.
4	5. The Authority finds that the requests outline above are appropriate under NAC
5	706.465.
6	6. Pursuant to NAC 706.465, no change in the holding of shares in the company
7	and no change in the trustees or beneficiaries of the trusts can take place without the prior
8	approval of the Taxicab Authority.

10	GOOD CAUSE APPEARING THEREFORE,
11	IT IS HEREBY ORDERED that pursuant to NAC 706.465, the requested transfer of four
12	(4) voting shares of Henderson Taxi to the Trust is approved;
13	IT IS FURTHER ORDERED that the requested transfer of 196 non-voting shares of
14	Henderson Taxi to the Trust is approved;
15	IT IS FURTHER ORDERED that Larry E. Bell, Jr. and Kathleen Jo Kusler are approved
16	to serve as successor co-trustees of the Trust.
