19 The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact  
20 and conclusions of law.

21 1. On the 26th day of January, 2010, a public hearing was held regarding the  
22 above-entitled matter (the "Event"), in compliance with the provisions of the Nevada Open  
23 Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised  
24 Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested  
25 parties appeared and were heard.

26 2. The Taxicab Authority is authorized to allocate temporary additional medallions,  
27 pursuant to NRS 706.8824 and 706.88245, whenever circumstances require a temporary  
28 increase in the number of taxicabs allocated.

3. Staff recommended allocation of temporary, special-event medallions for the  
above-referenced event, based upon the estimated attendance, and the nature of the  
attendees and the events. Staff recommended an allocation of 15 additional medallions per

1 company on Friday, February 5, 2010 from 12:00 P.M.- 12:00 A.M.; 10 additional medallions  
2 per company on Saturday, February 6, 2010 from 7:00 A.M.-7:00 P.M. and 10 additional  
3 medallions from 12:00 P.M.- 12:00 A.M; 10 additional medallions per company on Sunday,  
4 February 7, 2010 from 7:00 A.M.-7:00 P.M. and 10 additional medallions from 12:00 P.M.-  
5 12:00 A.M; 5 additional medallions per company on Monday February, 8, 2010 from 7:00  
6 A.M.-7:00 P.M. and 5 additional medallions from 12:00 P.M.- 12:00 A.M. Staff amended its  
7 recommendations during the hearing to change "12:00 A.M." to "2:00 A.M." for all above-  
8 listed timeframes.

9 4. The following filed Petitions to Intervene and all were permitted to intervene and  
10 be heard: (1) Lucky Cab Company, (2) Desert Cab Company, (3) Western Cab Company, (4)  
11 Frias Holding Company, (5) Nellis Cab Company, (6) Yellow/Checker/Star Cab Companies,  
12 (7) A Cab, LLC, (8) Whittlesea Blue/Henderson Taxi, (9) United Steelworkers Union and (10)  
13 ITPE Union. No representative from Nellis Cab Company was present at the hearing.

14 5. Based upon staff's recommendations, as well as the testimony and  
15 recommendations of the Intervenors, the Board finds that there is a need for temporary,  
16 additional taxicabs to service the public at the Events, which the Board, accordingly, finds  
17 should be addressed by a temporary allocation of additional medallions.

18 6. Pursuant to NRS 706.88245(2), the Board is required to allocate the temporary  
19 increase in medallions equally among the certificate holders. All companies, except those  
20 specifically prohibited by their certificates, are entitled to share in the temporary additional  
21 allocation, which temporary additional medallions are only to be used in each company's  
22 certificated area.

23 THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary  
24 additional medallions to address the need for additional taxicabs for the above-referenced  
25 events, as follows:

26 **FRIDAY, FEBRUARY 5, 2010**  
27 10 medallions per company  
28 12:00 P.M. to 2:00 A.M.  
(any 12-hour period)
