The TAXICAB AUTHORITY makes the following findings of fact and conclusions of law:

1. On the 26th day of January, 2010, a public hearing was held in the above-entitled matter, in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, and Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC).
2. At this duly noticed meeting, Agenda Item No. 7 was listed as captioned above.
3. The Applicant, THE AMANDA BERNEY 2004 GENERATIONS TRUST, seeks authorization from the Taxicab Authority board to transfer 2.635 non-voting shares of Whittlesea Bell Cab Company, a Nevada corporation to Whittlesea Bell Cab Company. Whittlesea Bell

1 currently holds a Certificate of Public Convenience and Necessity issued by the Taxicab
2 Authority.

3 4. No parties have sought leave to intervene in this application.

4 5. The Authority finds that the requests outline above are appropriate under NAC
5 706.465.

6 6. Pursuant to NAC 706.465, no change in the holding of shares in the company
7 and no change in the trustees or beneficiaries of the trusts can take place without the prior
8 approval of the Taxicab Authority.

10 GOOD CAUSE APPEARING THEREFORE,

11 IT IS HEREBY ORDERED that pursuant to NAC 706.465, the requested transfer of
12 2,635 non-voting shares from The Amanda Berney 2004 Generations Trust to Whittlesea Bell
13 Cab Company is approved.
