The TAXICAB AUTHORITY makes the following findings of fact and conclusions of law:

1.       On the 27<sup>th</sup> day of April, 2010, a public hearing was held in the above-entitled matter, in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, and Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC).
2.       At this duly noticed meeting, Agenda Item No. 7 was listed as captioned above.
3.       The Applicant, PETER ELIADES, Trustee, seeks authorization from the Taxicab Authority board to transfer his voting shares of Nevada Yellow Cab Corporation, Nevada Checker Cab Corporation and Nevada Star Corporation, to the Eliades Survivor Trust dated

1 October 30, 2008 ("the Trust"). Nevada Yellow Cab Corporation, Nevada Checker Cab  
2 Corporation and Nevada Star Corporation each currently hold a Certificate of Public  
3 Convenience and Necessity issued by the Taxicab Authority.

4 4. The Authority finds that the requests outline above are appropriate under NAC  
5 706.465.

6 5. Pursuant to NAC 706.465, no change in the holding of shares in the company and  
7 no change in the trustees or beneficiaries of the trusts can take place without the prior approval  
8 of the Taxicab Authority.

9 GOOD CAUSE APPEARING THEREFORE,

10 IT IS HEREBY ORDERED that pursuant to NAC 706.465, the requested transfer of the  
11 voting shares from Peter Eliades to the Trust is approved.
