17 IT APPEARING THAT on the 29th day of June, 2010, a public hearing was held in the
18 above-entitled matter, in compliance with the provisions of the Nevada Open Meeting Law, the
19 Nevada Administrative Procedure Act, and Chapter 706 of the Nevada Revised Statutes
20 (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties
21 appeared and were heard.

22 IT FURTHER APPEARING that the following parties moved to intervene:,
23 WHITTLESEA BLUE/HENDERSON TAXI, DESERT CAB COMPANY, WESTERN CAB
24 COMPANY, LUCKY CAB COMPANY, YELLOW/CHECKER/STAR CAB COMPANIES, A
25 CAB, LLC, , NELLIS CAB COMPANY, FRIAS HOLDING COMPANY, ITPE UNION, and
26 UNITED STEELWORKERS UNION. Each of the moving parties was permitted to intervene.

27 IT FURTHER APPEARING that the Authority received proof regarding the circumstances
28 affecting the interests of the taxicab industry, drivers and customers in Clark County, and that

1 the Authority having duly considered the evidence, fully considered the law and being fully
2 advised in the premises makes its Findings of Fact, Conclusions of Law and Order as follows:

3 **FINDINGS OF FACT**

4 1. The Taxicab Authority, through Kelly Kuzik, recommends no additional medallions be
5 allocated at the present time.

6 2. Representatives for all Interveners were present and provided comment.

7 3. All Interveners testified that they support the Taxicab Authority's recommendation with
8 the exception of A Cab, which advocated the addition of three (3) additional geographically
9 restricted medallions and one (1) additional special service medallion.

10 4. Members of the public testified during public comment.

11 5. If any of the foregoing findings of fact is more properly deemed a conclusion of law, it
12 may be so construed.

13 **CONCLUSIONS OF LAW**

14 1. This matter was held in accordance with applicable Nevada Revised Statutes.

15 2. The Taxicab Authority has the authority to review and alter the number of medallions
16 issued to taxicab companies, pursuant to NRS 706.8819(1)(d).

17 3. Conditions within the Taxicab industry do not warrant the addition of any additional
18 medallions at the present time.

19 4. The area to be affected by the Order is Clark County, Nevada.

20 5. The interests, welfare, convenience, necessity and well being of the customers of
21 taxicabs are better served by this Order.

22 6. If any of the foregoing conclusions is more appropriately construed a finding of fact, it
23 may be so construed.
