The TAXICAB AUTHORITY makes the following findings of fact and conclusions of law:

1.       On the 29<sup>th</sup> day of June, 2010, a public hearing was held in the above-entitled matter, in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, and Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC).

2.       At this duly noticed meeting, Agenda Item No. 8 was listed as captioned above.

3.       The Applicant, THE GARY D. BELL, JR. 2004 GENERATIONS TRUST, dated December 22, 2004 ("the Trust"), seeks authorization from the Taxicab Authority board to transfer two (2) non-voting shares of Whittlesea-Bell, to Whittlesea-Bell. Whittlesea Bell is the

1 holding company for Whittlesea Blue Cab, which currently holds a Certificate of Public  
2 Convenience and Necessity issued by the Taxicab Authority.

3 4. The Authority finds that the requests outlined above are appropriate under NAC  
4 706.465.

5 5. Pursuant to NAC 706.465, no change in the holding of shares in the company and  
6 no change in the trustees or beneficiaries of the trusts can take place without the prior approval  
7 of the Taxicab Authority.

8 GOOD CAUSE APPEARING THEREFORE,

9 IT IS HEREBY ORDERED that, pursuant to NAC 706.465, the requested transfer of two  
10 (2) voting shares from the Trust to Whittlesea Bell is approved.
