**ORDER**

The TAXICAB AUTHORITY makes the following findings of fact and conclusions of law:

1. On the 28<sup>th</sup> day of September, 2010, a public hearing was held in the above-entitled matter, in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, and Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC).
2. At this duly noticed meeting, Agenda Item No. 7 was listed as captioned above.
3. The Applicant, AFRODITI ELIADES LEDSTROM, Trustee, seeks authorization from the Taxicab Authority board to transfer four-hundred ninety-five (495) shares of non-voting common stock in Nevada Yellow Cab Corporation, Nevada Checker Cab Corporation and Nevada Star Corporation, to four sub-trusts, as identified in the Applicant's petition. Applicant

1 contemplates transferring 123.75 shares to each sub-trust. Nevada Yellow Cab Corporation,  
2 Nevada Checker Cab Corporation and Nevada Star Corporation each currently hold a  
3 Certificate of Public Convenience and Necessity issued by the Taxicab Authority.

4 4. The Applicant also seeks the approval of JANET OSMAN JOHNSON to serve as  
5 a Trustee of the JE Irrevocable Grantor Trust – NAPHSIKA P. ELIADES OSMAN.

6 5. The Applicant also seeks the approval of RENEE ANJULI JOHNSON, KARINA  
7 ISABELLA RESENDEZ, LILLYANN ANGELIQUE RESENDEZ and AUBREY NICOLE WRIGHT  
8 as beneficiaries to the JE Irrevocable Grantor Trust and the PE Irrevocable Grantor Trust.

9 6. The Authority finds that the requests outlined above are appropriate under NAC  
10 706.465.

11 7. Pursuant to NAC 706.465, no change in the holding of shares in the company  
12 and no change in the trustees or beneficiaries of the trusts can take place without the prior  
13 approval of the Taxicab Authority.

14 GOOD CAUSE APPEARING THEREFORE,

15 IT IS HEREBY ORDERED that pursuant to NAC 706.465, the requested transfer of 495  
16 non-voting shares of Nevada Yellow Cab Corporation, Nevada Checker Cab Corporation and  
17 Nevada Star Corporation to the sub-trusts identified in the Petition is approved;

18 IT IS FURTHER ORDERED that Applicant's request that JANET OSMAN JOHNSON be  
19 approved to serve as a Trustee of the JE Irrevocable Grantor Trust – NAPHSIKA P. ELIADES
