22 The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact  
23 and conclusions of law.

24 1. On the 7th day of December, 2010, a public hearing was held regarding the  
25 above-entitled matter (the "Event"), in compliance with the provisions of the Nevada Open  
26 Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised  
27 Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested  
28 parties appeared and were heard.

1. The Taxicab Authority is authorized to allocate temporary additional medallions,  
pursuant to NRS 706.8824 and 706.88245, whenever circumstances require a temporary  
increase in the number of taxicabs allocated.

1           3.     The following filed Petitions to Intervene and all were permitted to intervene and  
 2 be heard: (1) Lucky Cab Co., (2) Western Cab Company, (3) A Cab LLC, (4) United  
 3 Steelworkers Union , (5) ITPE Union.

4           5.     Based upon the arguments, testimony and evidence presented to the Board by  
 5 Applicant Frias Companies, Staff of the Taxicab Authority and the Interveners, the Board finds  
 6 that there is a need for temporary, additional taxicabs to service the public at the Event, which  
 7 the Board, accordingly, finds should be addressed by a temporary allocation of additional  
 8 medallions.

9           6.     Pursuant to NRS 706.88245(2), the Board is required to allocate the temporary  
 10 increase in medallions equally among the certificate holders. All companies are entitled to  
 11 share in the temporary additional allocation.

12           THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary  
 13 additional medallions to address the need for additional taxicabs for the above-referenced  
 14 events, as follows:

15                           **FRIDAY, DECEMBER 10, 2010**

16                                 5 medallions per company  
 17                                     Any 12-hour period

18                           **SATURDAY, DECEMBER 11, 2010**

19                                 5 medallions per company  
 20                                     Any 12-hour period

21                           **SUNDAY, DECEMBER 12, 2010**

22                                 3 medallions per company  
 23                                     Any 12-hour period

24           IT IS FURTHER ORDERED that the authorized additional cabs may be put into service  
 25 only during the times and dates set forth herein.
