4. The following filed Petitions to Intervene and all were permitted to intervene and be heard: (1) Whittlesea Blue/Henderson Taxi, (2) Desert Cab Company, (3) Yellow/Checker/Star Cab Companies, (4) Nellis Cab Company, (5) A-Cab, LLC, (6) Lucky Cab Company, (7) Western Cab Company, (8) Frias Holding Companies, (9) United Steelworkers Union, and (10) ITPE Union.

8 5. Based upon the testimony presented to the Board, the Board finds that there is a
9 need for temporary, additional taxicabs to service the public at the Event, which the Board,
10 accordingly, finds should be addressed by a temporary allocation of additional medallions.

6. Pursuant to NRS 706.88245(2), the Board is required to allocate the temporary
increase in medallions equally among the certificate holders. All companies are entitled to
share in the temporary additional allocation, which temporary additional medallions are only to
be used in each company's certificated area.

THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary
additional medallions to address the need for additional taxicabs for the above-referenced
events, as follows:
