16 The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact
17 and conclusions of law.

18 1. On the 14th day of December, 2010, a public hearing was held regarding the
19 above-entitled matter (the “Event”), in compliance with the provisions of the Nevada Open
20 Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised
21 Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested
22 parties appeared and were heard.

23 2. The Taxicab Authority is authorized to allocate temporary additional medallions,
24 pursuant to NRS 706.8824 and 706.88245, whenever circumstances require a temporary
25 increase in the number of taxicabs allocated.

26 3. Taxicab Authority Staff recommended the allocation of temporary, special-event
27 medallions for the above-referenced Event beginning at 6:00 p.m. on December 31, 2010 and
28 concluding at 6:00 a.m. January 1, 2010, based upon it’s estimated attendance, the nature of

1 the attendees and the event, statistics from recent special event allocations and past
2 allocations for this event.

3 4. The following filed Petitions to Intervene and all were permitted to intervene and
4 be heard: (1) Whittlesea Blue/Henderson Taxi, (2) Desert Cab Company, (3)
5 Yellow/Checker/Star Cab Companies, (4) Nellis Cab Company, (5) A-Cab, LLC, (6) Lucky
6 Cab Company, (7) Western Cab Company, (8) Frias Holding Companies, (9) United
7 Steelworkers Union, and (10) ITPE Union.

8 5. Based upon the testimony presented to the Board, the Board finds that there is a
9 need for temporary, additional taxicabs to service the public at the Event, which the Board,
10 accordingly, finds should be addressed by a temporary allocation of additional medallions.

11 6. Pursuant to NRS 706.88245(2), the Board is required to allocate the temporary
12 increase in medallions equally among the certificate holders. All companies are entitled to
13 share in the temporary additional allocation, which temporary additional medallions are only to
14 be used in each company's certificated area.

15 THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary
16 additional medallions to address the need for additional taxicabs for the above-referenced
17 events, as follows:

18 **THURSDAY, DECEMBER 30, 2010**

19 5 medallions per company
12:00 PM to 2:00 AM
(any 12 hour period)

20 **FRIDAY, DECEMBER 31, 2010**

21 8 medallions per company
7:00 AM to 7:00 PM
and

22 14 medallions per company
23 6:00 PM to 6:00 AM

24 **SATURDAY, JANUARY 1, 2010**

25 7 medallions per company
7:00 AM to 7:00 PM
and

26 10 medallions per company
27 12:00 PM to 2:00 AM
28 (any 12 hour period)
