16 The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact
17 and conclusions of law.

18 1. On the 10th day of February, 2011, a public hearing was held regarding the
19 above-entitled matter (the "Event"), in compliance with the provisions of the Nevada Open
20 Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised
21 Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested
22 parties appeared and were heard.

23 2. The Taxicab Authority is authorized to allocate temporary additional medallions,
24 pursuant to NRS 706.8824 and 706.88245, whenever circumstances require a temporary
25 increase in the number of taxicabs allocated.

26 3. Staff recommended the allocation of temporary, special-event medallions for the
27 above-referenced Event, based upon the estimated attendance, and the nature of the
28 attendees and the events.
