17 The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact
18 and conclusions of law.

19 1. On the 29th day of November, 2011, a public hearing was held regarding the
20 above-entitled matter (the “Event”), in compliance with the provisions of the Nevada Open
21 Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised
22 Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested
23 parties appeared and were heard.

24 2. The Taxicab Authority is authorized to allocate temporary additional medallions,
25 pursuant to NRS 706.8824 and 706.88245, whenever circumstances require a temporary
26 increase in the number of taxicabs allocated.

27 3. The Event begins on Friday December 30, 2011 and concludes on Sunday
28 January 1, 2012.

4. The following filed Petitions to Intervene and all were permitted to intervene and
be heard: (1) Desert Cab Company, (2) United Steelworkers Union, (3) Ace Cab, Inc./Union

1 Cab Co./ A NLV Cab Co./ Vegas-Western Cab Inc. /Virgin Valley Cab Company, Inc., (4)
2 Nellis Cab Company, (5) Whittlesea Blue/Henderson Taxi, (6) Yellow/Checker/Star Cab
3 Company, (7) Western Cab Company, (8) A Cab, LLC, (9) Lucky Cab Company, and (10)
4 ITPE Union.

5 5. Based upon the testimony presented to the Board, the Board finds that there is a
6 need for temporary, additional taxicabs to service the public at the Event, which the Board,
7 accordingly, finds should be addressed by a temporary allocation of additional medallions.

8 6. Pursuant to NRS 706.88245(2), the Board is required to allocate the temporary
9 increase in medallions equally among the certificate holders. All companies are entitled to
10 share in the temporary additional allocation, which temporary additional medallions are only to
11 be used in each company's certificated area.

12 THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary
13 additional medallions to address the need for additional taxicabs for the above-referenced
14 events, as follows:

15 **FRIDAY, DECEMBER 30, 2011**

16 10 medallions per company
17 7:00 AM to 7:00 PM

18 *and*

19 10 medallions per company
20 12:00 PM (noon) to 2:00 AM
21 (any 12 hour period)

22 **SATURDAY, DECEMBER 31, 2011**

23 10 medallions per company
24 7:00 AM to 7:00 PM

25 *and*

26 10 medallions per company
27 6:00 PM to 6:00 AM
28 (any 12 hour period)

SUNDAY, JANUARY 1, 2012

5 medallions per company
7:00 AM to 7:00 PM

and

5 medallions per company
12:00 PM (noon) to 2:00 AM
(any 12 hour period)

1 IT IS FURTHER ORDERED that the authorized additional cabs may be put into service
2 only during the times and dates set forth herein.
