ORDER

The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

1. On the 29th day of November, 2011, a public hearing was held regarding the above-entitled matters (the "Events"), in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties appeared and were heard.

2. The Taxicab Authority is authorized to allocate temporary additional medallions, pursuant to NRS 706.88245, whenever circumstances require a temporary increase in the number of taxicabs allocated, pursuant to NRS 706.8824.

3. The Event runs from January 23, 2012 to January 28, 2012.

4. The following filed Petitions to Intervene and all were permitted to intervene and be heard: (1) Desert Cab Company, (2) United Steelworkers Union, (3) Ace Cab, Inc./Union Cab Co./ A NLV Cab Co./ Vegas-Western Cab Inc. /Virgin Valley Cab Company, Inc., (4)

1 Nellis Cab Company, (5) Whittlesea Blue/Henderson Taxi, (6) Yellow/Checker/Star Cab
2 Company, (7) Western Cab Company, (8) A Cab, LLC, (9) Lucky Cab Company, and (10)
3 ITPE Union.

4 5. Based upon the testimony presented to the Board, the Board finds that there is a
5 need for temporary, additional taxicabs to service the public at the Events which the Board,
6 accordingly, finds should be addressed by a temporary allocation of additional medallions.

7 6. Pursuant to NRS 706.88245(2), the Board is required to allocate the temporary
8 increase in medallions equally among the certificate holders. All companies are entitled to
9 share in the temporary additional allocation, which temporary additional medallions are only to
10 be used in each company's certificated area.

11 THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary
12 additional medallions to address the need for additional taxicabs for the above-referenced
13 events, as follows:

14 **TUESDAY, JANUARY 24, 2012**

15 5 medallions per company
16 7:00 AM to 7:00 PM

17 *and*

18 5 medallions per company
19 12:00 PM to 2:00 AM
20 (any 12 hour period)

21 **WEDNESDAY, JANUARY 25, 2012**

22 5 medallions per company
23 7:00 AM to 7:00 PM

24 *and*

25 5 medallions per company
26 12:00 PM to 2:00 AM
27 (any 12 hour period)

28 **THURSDAY, JANUARY 26, 2012**

5 medallions per company
7:00 AM to 7:00 PM

1 IT IS FURTHER ORDERED that the authorized additional cabs may be put into service
2 only during the times and dates set forth herein.
