15 The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact
16 and conclusions of law.

17 1. On the 24th day of January, 2012, a public hearing was held regarding the
18 above-entitled matter (the "Event"), in compliance with the provisions of the Nevada Open
19 Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised
20 Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested
21 parties appeared and were heard.

22 2. The Taxicab Authority is authorized to allocate temporary additional medallions,
23 pursuant to NRS 706.8824 and 706.88245, whenever circumstances require a temporary
24 increase in the number of taxicabs allocated.

25 3. The following filed Petitions to Intervene and all were permitted to intervene and
26 be heard: (1) Nellis Cab Company, (2) Yellow/Checker/Star Cab Companies, (3) Desert Cab
27 Company, (4) Ace Cab, Inc., Union Cab Co., A NLV Cab Co., Vegas-Western Cab, Inc., Virgin
28 Valley Cab Company, Inc., (5) Lucky Cab Company, (6) Whittlesea Blue/Henderson Taxi, (7)
A Cab, LLC, (8) United Steelworkers Union, and (9) ITPE Union. Western Cab Company's

1 petition to intervene was also granted, however no representative of Western Cab Company
2 was present for the Board's meeting.

3 4. Taxicab Authority staff participated and presented data and information to the
4 Board.

5 5. Based upon the evidence and recommendations submitted by the Intervenors
6 and Taxicab Authority staff, the Board finds that there is a need for temporary, additional
7 taxicabs to service the public at the Events, which the Board, accordingly, finds should be
8 addressed by a temporary allocation of additional medallions.

9 6. Pursuant to NRS 706.88245(2), the Board is required to allocate the temporary
10 increase in medallions equally among the certificate holders. All companies, except those
11 specifically prohibited by their certificates, are entitled to share in the temporary additional
12 allocation, which temporary additional medallions are only to be used in each company's
13 certificated area.

14 THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary
15 additional medallions to address the need for additional taxicabs for the above-referenced
16 events, as follows:

17 **FRIDAY, FEBRUARY 3, 2012**

18 4 medallions per company
19 12:00 P.M. to 2:00 A.M.
(any 12-hour period)

20 **SATURDAY, FEBRUARY 4, 2012**

21 4 medallions per company
22 7:00 AM to 7:00 PM
and
23 4 medallions per company
24 12:00 PM to 2:00 AM
(any 12-hour period)

25 IT IS FURTHER ORDERED that the authorized additional medallions may be put into
26 service only during the times and dates set forth herein.

1 IT IS FURTHER ORDERED that in order to assist the Taxicab Authority in assessing
2 the impact of the allocation of special event medallions, the Board requests that detailed
3 medallion productivity reports be submitted by each company. It is further requested that the
4 "Special Event Template (Excel)" available under the "Forms" tab on the Taxicab Authority
5 website be used for the sake of uniformity and totaling data.
