The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

1. On the 28th day of February, 2012, a public hearing was held regarding the above-entitled matter (the "Event"), in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties appeared and were heard.

2. The Taxicab Authority is authorized to allocate temporary additional medallions, pursuant to NRS 706.8824 and 706.88245, whenever circumstances require a temporary increase in the number of taxicabs allocated.

3. Staff recommended no allocation of temporary, special-event medallions for the above-referenced Event.

4. The following filed Petitions to Intervene and all were permitted to intervene and be heard: (1) Yellow/Checker/Star Cab Companies, (2) Desert Cab Company, (3) Ace Cab, Inc./Union Cab Co./ A NLV Cab Co./ Vegas-Western Cab Inc. /Virgin Valley Cab Company, Inc, (4) Nellis Cab Company, (5) United Steelworkers Union, (6) Lucky Cab Company, (7) A

1 Cab, LLC, (8) Western Cab Company, (9) Whittlesea Blue/Henderson Taxi, and (10) ITPE  
2 Union.

3 5. Based upon the testimony and recommendations of staff and the Intervenors,  
4 the Board finds that there is not a need for temporary, additional taxicabs to service the public  
5 at the Event.

6 THEREFORE, IT IS HEREBY ORDERED that no additional temporary medallions be  
7 allocated to service the Event.
