## NOTICE OF WORKSHOP TO SOLICIT COMMENTS ON PROPOSED REGULATIONS

The Nevada Taxicab Authority is proposing the adoption, amendment, and/or repeal of regulations pertaining to Assembly Bill 487 ("AB 487") of the 79<sup>th</sup> (2017) Nevada Legislative Session. A workshop has been set for **9:00 a.m. on November 30, 2017**. The public may attend this workshop at the Nevada Taxicab Authority Hearing Room located at 2080 East Flamingo, Suite 114, Las Vegas, Nevada 89119.

The purpose of this workshop is to determine the impact of the proposed regulations on small businesses and to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations:

1) Clarifying the meaning of NRS 706.8846(3) to include (a) permitting the Authority to adopt alternate routes and (b) allow drivers to use a different route other than the most direct route for their passengers.


