AMENDED NOTICE TO DETERMINE SMALL BUSINESS IMPACT

The Nevada Taxicab Authority is proposing the adoption, amendment, and/or repeal of regulations pertaining to Assembly Bill 487 ("AB 487") of the 79th Nevada Legislative Session. The general topic that may be addressed by the proposed regulations include:

- Clarifying the meaning of NRS 706.8846(3) to include (a) permitting the Authority to adopt alternate routes and (b) allowing drivers to use a different route other than the most direct route for their passengers.

Pursuant to NRS 233B.0608(1), any agency proposing the adoption, amendment, and/or repeal of regulations within the Nevada Administrative Code needs to determine if this amendment impacts small businesses. A small business means a business conducted for profit that employs fewer than 150 full-time or part-time employees. See NRS 233B.0382. If you are a small business that will be impacted by the proposed regulations, please contact the Nevada Taxicab Authority in writing by the **close of business day on November 15, 2017** with your concerns and ways this proposed Amendment will directly affect your company. The Nevada Taxicab Authority will continue to collect both written and verbal comments even after this date and throughout the regulation making process. 
