SMALL BUSINESS IMPACT STATEMENT

The Taxicab Authority believes that its proposed adoption, amendment, and/or repeal of regulations within the Nevada Administrative Code chapter 706 implementing changes contained in Assembly Bill 487 ("AB 487") of the 79th (2017) Nevada Legislative Session and updating already existing regulations do not create a negative economic impact on small businesses.

The Taxicab Authority sent out a general notice to small businesses asking whether these proposed regulations will impose a direct and significant economic burden upon them. Having received no written responses, the Taxicab Authority does not believe the proposed regulations significantly impair the ability of small businesses to operate, form, and/or expand.

On February 13, 2018, the Taxicab Authority posted its *Notice to Determine Small Business Impact* to the locations, companies, and businesses as listed in the notice. The Taxicab Authority requested small businesses to submit written responses no later than February 20, 2018 describing their concerns and expressing how these proposed regulations may negatively impact them. The Taxicab Authority received no written responses or concerns from small businesses as of the deadline date.

Small businesses have yet another opportunity to address whether the proposed regulations will negatively impact them during a scheduled workshop on **Monday, March 12, 2018, at 9:00 a.m. located at 2080 East Flamingo, Suite 114, Las Vegas, Nevada 89119**. Small businesses, at this time, may orally express their concerns and discuss how the proposed regulations will impair their ability to operate, form, or expand their businesses. The Taxicab Authority will address and incorporate any oral comments received during its workshop into its final small business impact statement.

Based upon the foregoing, the Taxicab Authority does not believe the proposed regulations create a negative economic impact on small business hindering their ability to operate, form, and/or expand. I certify that, to the best of my knowledge and belief, to the information contained in this statement.
