#### **PRE-TRIALS:**

##### ***1. When are pre-trials scheduled?***

Pre-trials are scheduled for ***Tuesday afternoons (1 p.m. or 3 p.m.)*** and ***Thursday mornings (7:30 a.m. or 9:30 a.m.)***. The Taxicab Authority will have two (2) calendars, as indicated, on each day.

##### ***2. What are pre-trials?***

Pre-trials are your first time to attend court. You will have the opportunity to resolve your case or set the matter for trial. The Deputy Attorney General will be present to speak with you about your options and may negotiate the fine for your citation. Failure to attend court will result in a default judgment against you. If your ticket is not resolved at pre-trial, the matter will be set for a trial date.

##### ***3. May I settle my ticket before my pre-trial date?***

Yes, you may settle your ticket before your pre-trial date by coming to the Taxicab Authority Office located at 2090 East Flamingo Road, Suite 200, Las Vegas Nevada 89119.

- Pay ticket in full: Come at any time from 7:00 a.m. to 4:00 p.m..
- Negotiate the ticket: Settlement Conferences are Tuesdays, 1 p.m. to 4 p.m., or Thursdays, 9 a.m. to 12 p.m..

##### ***4. What happens if I fail to attend my pre-trial date?***

Failure to appear for your court date will result in a default judgment against you, the full fine of your ticket will be imposed, and your permit will be immediately suspended until you pay your fine balance in full. ***No payment plans will be accepted.***

##### ***5. Where do I pay my fines?***

Fines may be paid to the Taxicab Authority Office located at 2090 East Flamingo Road, Suite 200, Las Vegas Nevada 89119 during open business hours from 7:00 a.m. to 4:00 p.m..

#### **TRIALS:**

##### **1. *When are trials scheduled?***

Trials are scheduled three (3) days a week:

***Tuesday mornings (7:30 a.m. or 9:30 a.m.);***

***Wednesdays (all day); and***

***Thursday afternoons (1 p.m. or 3 p.m.).***

##### **2. *What are trials?***

Trial is your court day to present your defense. The Deputy Attorney General will present his or her case by calling witnesses and/or providing documents to the court. You will have the opportunity to see the documents and ask questions of the State's witnesses. Once the State finishes presenting its case, you may address the court and explain your side. You may also provide the court with your witnesses and/or documents. The Judge will decide whether the violation happened. If the violation happened, the Judge will impose a fine for each violation.

##### **3. *May I still negotiate my ticket fine on my trial day?***

No, ticket negotiations must be prior to your trial date. The State will seek the full fine amount of your ticket on the trial day. If you wish to negotiate the fine amount, you must come to the Settlement Conferences at the Taxicab Authority Office located at 2090 East Flamingo Road, Suite 200, Las Vegas Nevada 89119.

***\*\* Settlement Conferences are Tuesdays, 1 p.m. to 4 p.m., or Thursdays, 9 a.m. to 12 p.m.. \*\****

##### **4. *May I settle my ticket before my trial date?***

Yes, you may settle your ticket before your trial date by coming to the Taxicab Authority Office located at 2090 East Flamingo Road, Suite 200, Las Vegas Nevada 89119.

- **Pay ticket in full:** Come at any time from 7:00 a.m. to 4:00 p.m..
- **Negotiate the ticket:** Attend Settlement Conferences on Tuesdays, 1 p.m. to 4 p.m., or Thursdays, 9 a.m. to 12 p.m..

**5. *What happens if I fail to attend my trial date?***
