#### NOTICE OF INTENT TO ACT UPON A REGULATION

Notice of Hearing for the Amendment of Regulations of the

## **NEVADA TAXICAB AUTHORITY**

The Nevada Taxicab Authority will hold a public hearing at 9:00 a.m. January 24, 2012, at the

Nevada Taxicab Authority 1785 E. Sahara Avenue, Suite 200 Las Vegas, Nevada 89104

The purpose of the hearing is to receive comments from all interested persons regarding the amendment of regulations that pertain to chapter 706 of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of NRS 233B.0603:

- **1. The need for and the purpose of the proposed regulation or amendment**. The need for and the purpose of the proposed amendments are to eliminate any regulatory requirement regarding the precise location of the principal offices of the Nevada Taxicab Authority and to freely permit the Taxicab Authority to locate its principal office anywhere in Clark County.
- **2.** A description of the subjects and issues involved: The subject of this regulation is the elimination of the regulatory provision establishing the Taxicab Authority's principal office at 1785 E. Sahara Ave., Ste, 200, Las Vegas, Nevada. Any person may obtain a copy of the proposed amendment by submitting a request in writing to the Nevada Taxicab Authority, 1785 E. Sahara Ave., Ste. 200, Las Vegas, NV 89104.
- **3.** A statement identifying the methods used by the agency in determining the impact on a small business prepared pursuant to subsection 3 of NRS 233B.0608. The Nevada Taxicab Authority has solicited comments from the public prior to workshop meetings to determine that there will be no significant impact on small businesses.
- 4. The estimated economic effect of the regulation on the business which it is to regulate and on the public. These must be stated separately and in each case must include:
- (a) **Both adverse and beneficial effects**. The proposed amendment is directed solely at the location of the Taxicab Authority and does not economically affect the businesses regulated by the Taxicab Authority either adversely or beneficially.
- (b) Both immediate and long-term effects. There are no immediate or long-term economic effects.
- **5.** The estimated cost to the agency for enforcement of the proposed regulation. There is no estimated additional cost for the Nevada Taxicab Authority to enforce the proposed amendments.

- 6. A description of and citation to any regulations of other state or local governmental agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary. If the proposed regulation overlaps or duplicates a federal regulation, the notice must include the name of the regulating federal agency. The proposed amendment does not overlap or duplicate any regulations of other state or local governmental agencies.
- 7. If the regulation includes provisions which are more stringent than a federal regulation that regulates thesame activity, a summary of such provisions. No existing federal regulation regulates the same activity.
- 8. Whether the proposed regulation establishes a new fee or increases an existing fee. The proposed amendment does not establish a new fee or increase an existing fee.

Persons wishing to comment upon the proposed action of the Nevada Taxicab Authority may appear at the scheduled public hearing or may address their comments, data, views, or arguments, in written form, to Nevada Taxicab Authority. 1785 E. Sahara. Ste. 200. Las Vegas, Nevada 89104. Written submissions must be received by the Nevada Taxicab Authority on or before January 13, 2012. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Nevada Taxicab Authority may proceed immediately to act upon any written submissions.

A copy of this notice and the regulation to be adopted will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and the regulation to be adopted will be available at Office of the Nevada Taxicab Authority, 1785 E. Sahara, Ste. 200, Las Vegas, Nevada, and in all counties in which an office of the agency is not maintained, at the main public library, for inspection and copying by members of the public during business hours. This notice and the text of the proposed regulation are also available in the State of Nevada Register of Administrative Regulations, which is prepared and published monthly by the Legislative Counsel Bureau, pursuant to NRS 233B.0653, and on the Internet at http://www.leg.state.nv.us. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.



# PROPOSED REGULATION OF THE TAXICAB AUTHORITY OF THE DEPARTMENT OF BUSINESS AND INDUSTRY

#### LCB File No. R057-11

October 10, 2011

EXPLANATION - Matter in italics is new; matter in brackets [omitted material] is material to be omitted.

AUTHORITY: §1, NRS 233B.050 and 706.8818.

A REGULATION relating to the Taxicab Authority; revising provisions relating to the principal office of the Authority; and providing other matters properly relating thereto.

**Section 1.** NAC 706.879 is hereby amended to read as follows:

706.879 1. [The principal office of the Authority is 1785 East Sahara Avenue, Suite 200, Las Vegas, Nevada 89158.] The office of the Administrator will be open from 8:00 a.m. to 12:00 p.m. and 1:00 p.m. to 5:00 p.m. of each week day except Saturday, Sunday and legal holidays or other days declared by proper authority.

- 2. Regular sessions of the Authority are held in its principal office or such other place as the Authority may from time to time specify, at such times as the Authority may designate.
- 3. All formal written communications and documents must be addressed to the Taxicab Authority and not to individual members of the Authority or its staff. All communications and documents are deemed to be officially received only when delivered at the office of the Authority. Formal or informal communications from the Authority must be signed by the responsible staff member or Authority.
- 4. Communications must contain the name and address of the communicant and must embrace but one subject. Informal communications must be properly identified.
