**ORDER**

The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

1. On October 8, 2013, a public hearing was held regarding the above-entitled matter (the "Event"), in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties appeared and were permitted to be heard.
2. The Taxicab Authority is authorized to allocate temporary additional medallions, pursuant to NRS 706.88245, whenever circumstances require a temporary increase in the number of taxicabs allocated, pursuant to NRS 706.8824.

- 1 3. The Event runs from November 5, 2013 through November 8, 2013.
- 2 4. The following filed Petitions to Intervene and all were permitted to intervene and be
- 3 heard: (1) A Cab, LLC; (2) Yellow/Checker/Star Cab Companies; (3) Desert Cab
- 4 Company; (4) Whittlesea Blue and Henderson Taxi; (5) Ace Cab, Inc., Union Cab Co.,
- 5 A NLV Cab Company, Vegas-Western Cab, Inc., and Virgin Valley Cab Company, Inc.;
- 6 (6) Nellis Cab Company; (7) ITPE Union; (8) Lucky Cab Company; (9) Western Cab
- 7 Company.

- 9 5. Intervenors were allowed to present argument and evidence regarding the nature of
- 10 the event, the expected attendance of the event and the nature of the attendees of the
- 11 event.
- 12 6. Based upon the arguments, evidence and recommendations submitted by Intervenors,
- 13 the Board finds that there is a need for temporary, additional taxicabs to service the
- 14 public at the event, which the Board, accordingly, finds should be addressed by a
- 15 temporary allocation of additional medallions.
- 16
- 17 7. Pursuant to NRS 706.88245(2), any temporary allocation of additional medallions must
- 18 be apportioned equally among the certificate holders in the area to be affected by the
- 19 allocation.

20 THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary

21 additional medallions to address the need for additional taxicabs for the above-referenced

22 event, as follows:

24 4 medallions per company

25 7:00 AM to 7:00 PM

26 *and*

27 4 medallions per company

28 12:00 PM to 2:00 AM


