2. The Taxicab Authority is authorized to allocate temporary additional medallions, 1 pursuant to NRS 706.88245, whenever circumstances require a temporary increase in 2 the number of taxicabs allocated, pursuant to NRS 706.8824. 3 3. The Events are: 4 5 a. 2014 CONEXPO/CONAGG, held at LVCVA from Tuesday, March 4, 2014 6 through Saturday, March 8, 2014, with an estimated attendance of 130,000, and 7 b. NASCAR, held at the Las Vegas Motor Speedway from Thursday, March 6, 8 2014 through Sunday, March 9, 2014. 9 4. The following filed Petitions to Intervene and all were permitted to intervene and be 10 heard: (1) Sun Cab Inc. d/b/a Nellis Cab Company, (2) Yellow/Checker/Star Cab 11 Companies, (3) Ace Cab, Inc., Union Cab Co., A NLV Cab Co., Vegas-Western Cab, 12 13 Inc., and Virgin Valley Cab Company, (4) Lucky Cab Company, (5) Whittlesea 14 Blue/Henderson Taxi, (6) Desert Cab Company, (7) A Cab, LLC, (8) Boulder Cab, Inc. 15 d/b/a Deluxe Taxicab Service, (9) Western Cab Company, and (10) ITPE Union. 16 5. Intervenors and Staff were allowed to present argument and evidence regarding the 17 nature of the events, the expected attendance of the events and the nature of the 18 attendees of the events. 19 6. Based upon the arguments, evidence and recommendations submitted by Intervenors 20 and Staff, the Board finds that there is a need for temporary, additional taxicabs to 21 22 service the public at the Events, which the Board, accordingly, finds should be 23 addressed by a temporary allocation of additional medallions. 24 7. Pursuant to NRS 706.88245(2), any temporary allocation of additional medallions must 25 be apportioned equally among the certificate holders in the area to be affected by the 26 allocation. 27 28
