The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

1. On February 25, 2014, a public hearing was held regarding the above-entitled matters (the "Events"), in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties appeared and were permitted to be heard.

- 1 2. The Taxicab Authority is authorized to allocate temporary additional medallions,
2 pursuant to NRS 706.88245, whenever circumstances require a temporary increase in
3 the number of taxicabs allocated, pursuant to NRS 706.8824.
- 4 3. The Events are:
 - 5 a. 2014 CONEXPO/CONAGG, held at LVCVA from Tuesday, March 4, 2014
6 through Saturday, March 8, 2014, with an estimated attendance of 130,000, and
 - 7 b. NASCAR, held at the Las Vegas Motor Speedway from Thursday, March 6,
8 2014 through Sunday, March 9, 2014.
- 9 4. The following filed Petitions to Intervene and all were permitted to intervene and be
10 heard: (1) Sun Cab Inc. d/b/a Nellis Cab Company, (2) Yellow/Checker/Star Cab
11 Companies, (3) Ace Cab, Inc., Union Cab Co., A NLV Cab Co., Vegas-Western Cab,
12 Inc., and Virgin Valley Cab Company, (4) Lucky Cab Company, (5) Whittlesea
13 Blue/Henderson Taxi, (6) Desert Cab Company, (7) A Cab, LLC, (8) Boulder Cab, Inc.
14 d/b/a Deluxe Taxicab Service, (9) Western Cab Company, and (10) ITPE Union.
- 15 5. Intervenors and Staff were allowed to present argument and evidence regarding the
16 nature of the events, the expected attendance of the events and the nature of the
17 attendees of the events.
- 18 6. Based upon the arguments, evidence and recommendations submitted by Intervenors
19 and Staff, the Board finds that there is a need for temporary, additional taxicabs to
20 service the public at the Events, which the Board, accordingly, finds should be
21 addressed by a temporary allocation of additional medallions.
- 22 7. Pursuant to NRS 706.88245(2), any temporary allocation of additional medallions must
23 be apportioned equally among the certificate holders in the area to be affected by the
24 allocation.

2 additional medallions to address the need for additional taxicabs for the above-referenced
3 events, as follows:

21 5 medallions per company
22 12:00 PM to 2:00 AM
23 (any 12-hour period)

24 **FRIDAY, MARCH 7, 2014**

27 5 medallions per company
28 7:00 AM to 7:00 PM
