The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

FINDINGS OF FACT

1. On February 26, 2015, a public hearing was held in the above-entitled matter in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, and Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time at which time all interested parties appeared and were permitted to be heard.

1 2. The following filed Petitions to Intervene and all were permitted to intervene and be
2 heard: (1) Desert Cab Company, (2) Nellis Cab Company, (3) ITPE Union, (4)
3 Whittlesea Blue/Henderson Taxi, (5) Yellow/Checker/Star Cab Companies, (6)
4 Western Cab Company, (7) Lucky Cab Company, (8) Deluxe Cab Company, (9) Ace
5 Cab, Inc., Union Cab Co., A NLV Cab Co., Vegas-Western Cab Co. and Virgin Valley
6 Cab Company, Inc., and (10) A Cab, LLC.

7 3. Taxicab Authority staff presented their research and conclusions on 8 specific locations
8 and whether the original geographically restricted medallions (GEO-1) and/or the new
9 geographically restricted medallions created at the 2014 Annual Review of Medallions
10 (GEO-2) were able to pick up at that location.
