Dear Mr. Reynolds:

I'd like to give you a brief overview of my skills and experience. I am confident that I could bring value to the State of Nevada as the Division Administrator for the Taxicab Authority.

My relevant qualifications and experience include almost 20 years of law enforcement in various positions, with 7 years being employed in a progressive capacity in public transportation administration with the Colorado Public Utilities Commission. In my capacity at the Commission, I was responsible for the implementing the direction of the unit; including Safety and Compliance reviews of carrier and investigations of complaints filed with the Commission; including against Towing carriers, Household Goods Movers and storage, limousine companies, TNC's, Common Carriers, Contract Carriers, Nonemergency Medical Transportation. I supervised and directed up to 8 investigators in the performance of their duties. I was the resource expert for Commission controlled carriers for local jurisdictions including the enforcement of rules and Statues in the State of Colorado. I have extensive knowledge of report writing for administrative hearings and criminal procedures, including search warrants, affidavits, subpoenas, and complex reports of investigations, summonses, and Commission civil penalties. I have an expert knowledge of transportation-based technology having worked with both Uber and Lyft during enforcement activities, including being one of the first regulators to visit the Uber headquarters in San Francisco.

In my current position, I supervise the daily activities of several regulated professions including Nursing, Chiropractic, Dental, Physical Therapy and Combative Sports.
