



I. PURPOSE AND SCOPE

To establish a policy and agency guidelines that clarify the requirement of only one of driver type: either (employee) “TA Licensed Driver” or “Independent Contractor/Lease” driver, on a Taxicab Authority permit at any given time.

To establish a policy and agency guidelines to require a referral document from a company supporting any change in driver type and payment of \$10 processing fee.

II. POLICY

It is the policy of the Taxicab Authority to require a driver to report only one driver type when applying for, updating, replacing, or renewing a taxicab permit. The two options that will be clearly printed on the issued permit are either:

- TA Licensed Driver (employee driver of a company)
- Independent Contractor/Lease

The Administrator shall not authorize the option for a driver to list both driver types on a permit.

It is also the policy of the Taxicab Authority to require a referral document

from the company clearly stating their driver type. The referral may jointly contain other requirements covered in Policy # 312, "Driver Report of Change of Company".

The processing fee to update an unexpired Taxicab Authority permit for a change of driver type is \$10.00. It is the responsibility of the driver to inform the Taxicab Authority every time there is a change of their driver type, and update their permit information as such.

III. PROCEDURE

Referral Required Upon Change of Driver Type

1. Upon receiving a referral document from a taxicab driver to change their driver type, the licensing staff shall verify that it clearly contains the following information:
 - a.) the effective date of the referral
 - b.) that the driver is either an employee driver or an independent contractor/lessee, and not both
 - c.) the name of the company sending the referral
 - d.) name and signature of the company supervisor or manager

2. Licensing staff shall then verify the validity of the driver's TA permit, DMV driver's license, DOT physical form, and status of any unsettled administrative court fines (FTA's, suspensions):
 - a. If all documents supporting the current permit remain unexpired, proceed to the next step (# 3) for processing.
 - b. If one or more aspects of the current permit is expired, follow appropriate procedures, requirements, and fee schedule to update the permit (ex. follow renewal procedures for expired permits; or outstanding citation fines must be paid in full first before any other processing)

3. Licensing staff shall request payment for the published \$10 fee, and once received, process payment and issue an official receipt to the driver. The receipt shall reflect the appropriate payment method used by the driver.

4. Authorized staff shall update the driver's information in the designated licensing system. The driver's file will clearly state the driver type as written on the referral.
5. The driver will be issued an updated permit reflecting their current driver type.

I. PURPOSE AND SCOPE

To update and establish a policy and agency guidelines for the requirement of a company referral every time a taxicab driver, regardless of whether an employee driver or an independent contractor, changes companies, under the authority of Chapter 706 of the Nevada Revised Statutes and the Nevada Administrative Code.

II. POLICY

It is the policy of the Taxicab Authority to require a taxicab driver to obtain and submit a validated referral from the most current company for which they are either employed or leasing as an independent contractor, and update their unexpired permit to reflect their most current employer or lessor.

The processing fee to update an unexpired Taxicab Authority permit for a change of company is \$10.00. It is the responsibility of the driver to inform the Taxicab Authority every time they change companies, and update their permit information as such.

III. PROCEDURE

Referral Required for All Driver Types Upon Change of Company

1. Upon receiving a referral document from a taxicab driver to change companies, the licensing staff shall verify that it clearly contains the following information:
 - a.) the effective date of the referral
 - b.) that the driver is either an employee driver or an independent contractor/lessee, and not both
 - c.) the name of the company sending the referral
 - d.) name and signature of the company supervisor or manager
2. Licensing staff shall then verify the validity of the driver's TA permit, DMV driver's license, DOT physical form, and status of any unsettled administrative court fines (FTA's, suspensions):
 - a. If all documents supporting the current permit remain unexpired, proceed to the next step (# 3) for processing.
 - b. If one or more aspects of the current permit is expired, follow appropriate procedures, requirements, and fee schedule to update the permit (ex. follow renewal procedures for expired permits; or outstanding citation fines must be paid in full first before any other processing)

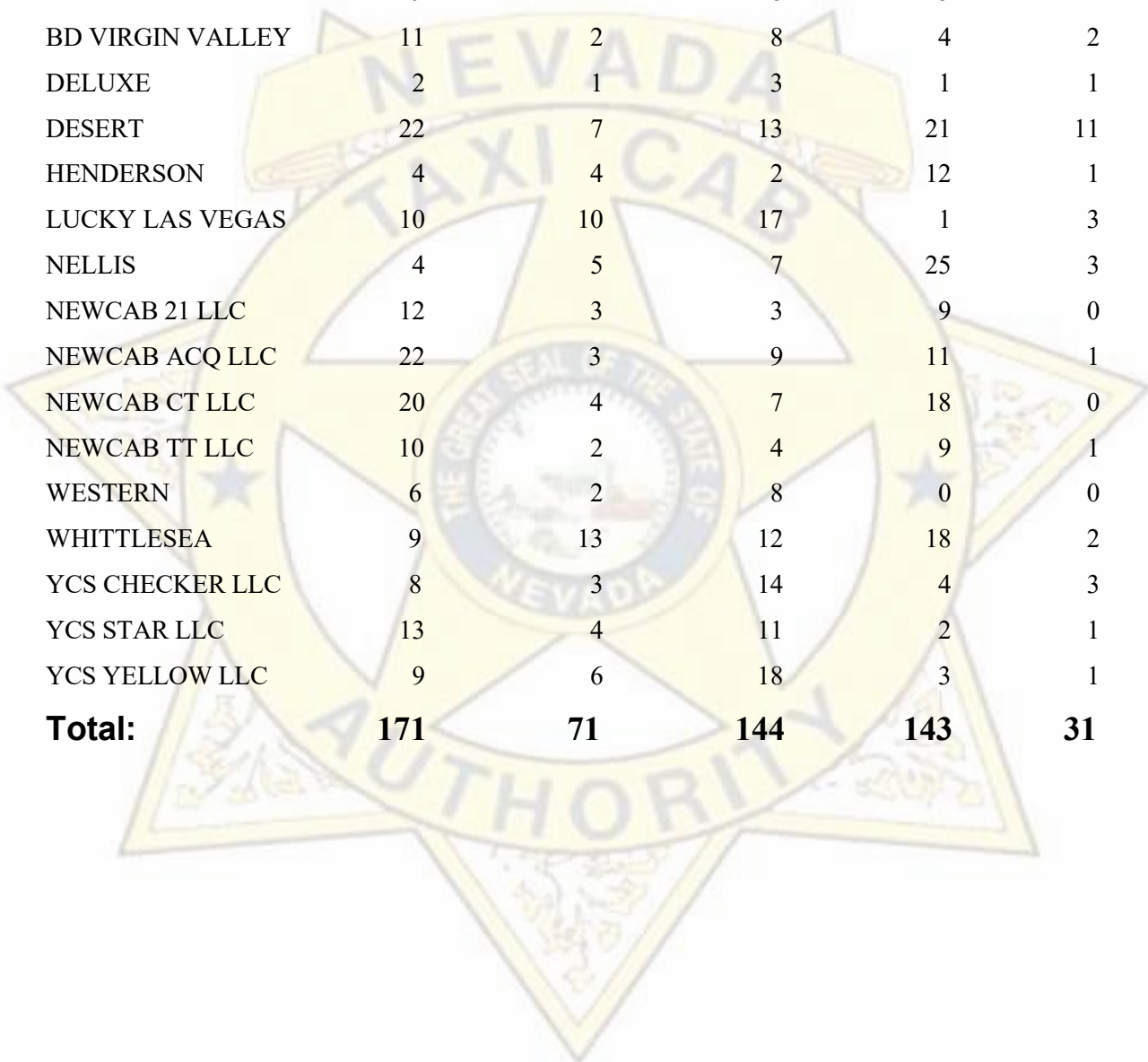




