To Start.

The applicant must bring with them several items to begin. They must have:

- A Referral from the company wanting to hire or lease to them.
- An acknowledgment that they have attended a “Drivers Awareness Program”
- Their Nevada Drivers License and a 3-year DMV printout.
- All 5 pages of the Medical Examiner's Certificate, (DOT Medical Report)

THE PROCESS

The Process.

When you come to the Taxicab Authority office, you will be greeted by our friendly staff.

- First, they will verify why you are there and if you have the required documents.
- Next, they will have you fill out an “Application Packet” consisting of several required forms. Be sure to fill them all out completely.
- Then it is required that you pass a twenty question English test.
- Next, they will run a preliminary background check and check over your application.

THE END RESULT

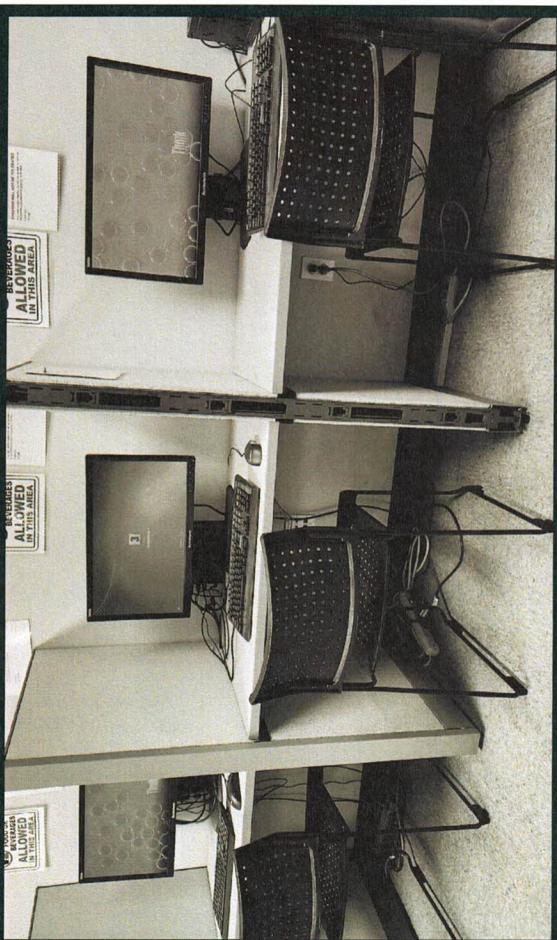
The End Result.

- If passed, you will pay the \$91.25 fee and they will process your fingerprints and submit them.
- You will then be given a 90-day “Temp Permit” while we wait for your FBI background to return. When the report returns, our Investigator will review them.
- If passed, you will return and receive your “Permanent Permit”. This permit is good for one (1) year from the start of the process.
- You must renew your permit annually.
- Do not let it expire, or you will have to go through this whole process again.

The Future.

- Starting September 1, 2023, the Taxicab Authority will no longer be doing fingerprints in-house. We will require them to be done at an approved vendor. The required form will be filled out and submitted to us.
- Updated forms and applications will be available on the website.
- By years end we hope to have the ability to be able to submit the applications and required documents online to start the process.
- Developing a new more practical English test.
- Developing a portal to pay online.

Previous medallion counts presented in the Nevada Taxicab Authority monthly statistics were based on an equivalency algorithm, which converted time restricted medallion totals into a quotient that was proportionally (i.e. mathematically) equivalent to that of medallions that could operate in Clark County 24 hours per day. The algorithm provided an easily understandable statistical mechanism which facilitated the comparison of seemingly disparate, incongruent, and/or dissimilar data points. The current medallion counts are based solely on the number of physical medallion plates issued to each Clark County certificated taxicab company.


