7 published by the Authority that a board meeting and public hearing will be held on February 19, 2025, at  
8 9:30 a.m., pursuant to NRS 706.8819 and 706.8828(6).

9           6. Petitioners are entitled, as a matter of right, to be heard at the public hearing on this  
10 matter

11           7. Petitioners wish to take part in the discussion and possible action regarding the Joint  
12 Application of Desert Cab Company and A-Cab Company. Petitioners wish to make certain our  
13 attorneys can represent us or speak at the hearing regarding the Joint Application

14           9. Petitioners therefore request that they be permitted to intervene and join in this  
15 proceeding and that they be served with copies of any and all pleadings, notices, papers and exhibits that  
16 have been or may be filed in these matters.

18           WHEREFORE, Petitioners respectfully request that this Authority enter an appropriate order  
19 which:

20           1. Grants permission to intervene and participate fully in any public hearing with respect to  
21 this matter, including the right to offer evidence of any kind, to examine and cross-examine witnesses  
22 and to make arguments and file briefs, as well as participate in all other aspects of this matter; and

23           2. For such other relief as appears just and proper.


