COME NOW Curb Mobility, LLC ("Petitioner") hereby petitions the Nevada State Taxicab Authority ("Authority") to intervene in the above referenced matter. The Authority's Board Meeting and Public Hearing is scheduled for February 19, 2025, at 9:30 a.m. This Petition is pursuant to NRS 706.881 et seq. and is supported by the following:

1. Petitioner is a limited liability company organized and existing under the laws of the State of Delaware with its principal place of business located at 11-11 34th Avenue, Long Island City, New York 11106.

3. Petitioner is a provider to common motor carriers holding Certificates of Public Convenience and Necessity issued by this Authority of technology, systems, software, hardware, methods, and tools that enable such common motor carriers to satisfy certain of this Authority's

1 requirements for Las Vegas, Nevada taxicabs to be equipped with certain technology and
2 systems.

3 4. Petitioner has learned from the Board Meeting Agenda and Notice of Public
4 Hearing published by the Authority that a board meeting and public hearing will be held on
5 February 19, 2025, at 9:30 am., pursuant to NRS 706.8819 and 706.8828(6).

7 5. Petitioner wishes to take part in the discussion and possible action regarding the
8 Joint Application of Desert Cab Company and A-Cab Company, which Joint Application (1)
9 contains certain statements of alleged fact regarding Petitioner and certain third-party patents that
10 are inaccurate, and (2) requests an action by the Authority that would significantly affect
11 Petitioner and the common motor carriers to whom Petitioner provides its products and services.

13 6. Petitioner wishes to make certain that its attorneys or other representatives can
14 speak at the hearing regarding the Joint Application.

15 7. Petitioner therefore requests that it be permitted to intervene and join in this
16 proceeding and that it be served with copies of any and all pleadings, notices, papers and exhibits
17 that have been or may be filed in this matter.

20 WHEREFORE, Petitioner respectfully requests that this Authority enter an appropriate
21 order that:

23 1. Grants permission to the Petitioner to intervene and participate fully in any public
24 hearing with respect to this matter, including the right to offer evidence of any kind, to examine
25 and cross-examine witnesses, and to make arguments and file briefs, as well as participate in all
26 other aspects of this matter; and

27 2. For such other relief as appears just and proper.
