**BEFORE THE STATE OF NEVADA TAXICAB AUTHORITY**

In the matter of the Amended Application of Desert Cab Co. to Adjust Taxicab Charges to Include a Pass Through Software License Charge.

**ORDER**

The Nevada Taxicab Authority ("**TA**") received the *Joint Application of Desert Cab Co. and A-Cab to Adjust Taxicab Charges to Include a Pass-Through Software License Charge; Supplement to the Joint Application of Desert Cab Co. and A-Cab Co. to Adjust Taxicab Charges to Include a Pass-Through Software License Charge*, and the *Amended Application of Desert Cab Co. To Adjust Taxicab Charges to Include a Pass-Through Software License Charge* (which resulted in the reopening of the Intervention filing period up to and including March 24, 2025.)

Pursuant to Nevada Administrative Code ("**NAC**") 706.894, the TA received requests for intervention and oppositions thereto as follows: YCS, NewCab & Taxi Management Petition to Intervene to Joint Application of Desert and A-Cab to Adjust Taxicab Charges; Curb Mobility Petition to Intervene to Joint Application of Desert and A-Cab to Adjust Taxicab Charges; Curb Mobility Interested Party Response to the Amended Application of Desert to Adjust Taxicab Charges; Curb Mobility Petition to Intervene to the Application of Desert to Adjust Taxicab Charges; Curb Mobility Amended Petition to Intervene to the Application of Desert to Adjust Taxicab Charges; IVSC IP Interested Party-Proposed Intervener Notice and Petition for Leave to Intervene in the Amended Application of Desert; Kaptyn Petition to

7           Showing a direct and substantial interest in the subject matter of the proceeding, each  
8 request for intervention is granted, subject to a later determination that an Intervenor is unduly  
9 broadening the issues, otherwise has no direct or substantial interest therein, or that the public  
10 interest does not require his or her participation therein.

11           The first prehearing conference in this matter to be conducted by the Hearing Officer  
12 will be held **APRIL 23, 2025, at 1:30 p.m. at the offices of the Nevada Taxicab Authority,**  
13 **2090 East Flamingo Road, Suite 200, 89119.** At that time the Hearing Officer will resolve  
14 any motions to associate pro hac vice under Supreme Court Rule 42, and pursuant to Nevada  
15 Administrative Code ("**NAC**") 706.933, resolve procedural issues all short of resolving any  
16 dispositive decisions surrounding whether this Application is granted or denied. The hearing  
17 officer will determine deadlines, discovery, prefiled testimony, the exchange of evidence,  
18 briefing, and the like, for the benefit of the Board processing the evidence that is assembled.

19           The Applicant will provide a Court Reporter at each Prehearing Conference and during  
20 any oral argument or hearing in this matter. A copy of the transcript from each conference,  
21 hearing or meeting will be provided timely by the Applicant to the TA at no charge. Each party  
22 will serve the other with all filings **by email AND U.S. mail**, with the original plus nine (9)  
23 copies delivered to the office of the Taxicab Authority for filing no later than 3:00 p.m. on the


