THIS MATTER came before the Nevada Taxicab Authority Board ("the Board"), at its regularly scheduled public meeting on May 21, 2025, ("the Hearing"), for the consideration of the temporary adoption/amendment/repeal of regulations for Chapter 706 (Nevada Taxicab Authority) of the Nevada Administrative Code ("NAC"). The Hearing was held at the Nevada State Business Center, located at 3300 West Sahara Avenue, Suite. 400, Las Vegas, Nevada 89102.

The proposed temporary new NAC regulations, temporary amendments to existing NAC provisions, and the temporary repeal of certain NAC regulations in Chapter 706 (collectively hereinafter the "Proposed Temporary Rules"), were discussed at length with the public and with the taxicab industry. The Nevada Taxicab Authority ("the Authority"), held two lengthy informal meetings with the industry in both January 2025 and February 2025, and two public Workshops with the Board in March 2025 and April 2025. Few changes were made to the Proposed Temporary Rules during the April 2025 Workshop with clarifications by staff being discussed. Changes from the March 2025 Workshop were publicly noticed and discussed during the April Workshop. Both Workshop agendas, the draft of the Proposed Temporary Rules and the Small Business Impact Statement were made available and noticed on the Authority's website, as well as at the Nevada State Library and Archives, the Nevada Legislature Administrative Regulation notices website and the State

1 of Nevada website. The Notice of Public Hearing and Notice of Hearing for Adoption of the
2 Proposed Temporary Rules were posted at the Business and Industry Building in Las Vegas, Nevada,
3 with the Capitol Police, the Clark County Commission, Las Vegas City Hall, and at the Authority's
4 office.

5 The Board conducted public comment sessions regarding the adoption of the Proposed
6 Temporary Rules during the Workshops and Public Hearings. Moreover, a number of opportunities
7 were given to the public to provide input as to any small business impacts that might result from
8 adoption of the Proposed Temporary Rules. The Authority informed the Board in the public hearings
9 that there were no financial impacts reported by the public on any of the Small Business Impact
10 Statements submitted by the public. Based on the evidence presented to the Board and following
11 consideration of the information presented during the Hearing, the Board hereby enters the following
12 Findings of Fact, Conclusions of Law and Order (the "**Decision**"):

13 **FINDINGS OF FACT**

14 1. The administrative record in this matter consists of the Notice of Public Hearing of
15 Intent to Act Upon Regulations, To Adopt Temporary Regulations/Temporarily Amend Regulations/
16 Temporarily Repeal Regulations from Chapter 706 (Nevada Taxicab Authority) of the Nevada
17 Administrative Code, the Public Hearing Notice to Adopt Temporarily Regulations/Temporarily
18 Amend Regulations/Temporarily Repeal Regulations from Chapter 706 (Nevada Taxicab Authority),
19 the public Board Meeting Notices and Agendas, the text of the Proposed Temporary Rules, the list of
20 Proposed Temporary Regulations to be adopted by reference, and the two Small Business Impact
21 Statements prepared by the Authority.

22 2. After discussion and deliberation, all members of the Board present at the Hearing,
23 having fully considered the law and being fully advised in the premises, accepted the Small Business
24 Impact Statement provided by the Authority, and voted unanimously in favor of a motion to approve
25 the adoption of the Proposed Temporary Rules as they were published and noticed for this May 21,
26 2025, hearing.

27 3. Furthermore, after discussion and deliberation, all members of the Board present at the
28 Hearing, having fully considered the law and being advised in the premises, voted unanimously in

1 favor of a motion to incorporate by reference the Nevada Transportation Authority's NAC's that were
2 published by reference and noticed for this May 21, 2025, hearing.

3 **CONCLUSIONS OF LAW**

4 1. The Hearing was held in compliance with the provisions of the Nevada Open Meeting
5 Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (the
6 "NRS") and Chapter 706 of the Nevada Administrative Code (the "NAC").

7 2. The geographic area subject to this Order is Clark County, Nevada.

8 3. The Board is duly constituted and may regulate the conduct of the taxicab business.
9 NRS 706.8818.

10 4. The Board has the authority to ensure that the traveling public have access to readily
11 available, safe and reliable transportation services. In furtherance of that objective, the Board
12 concludes the public interest will be served by the adoption of the Proposed Temporary Rules and
13 those incorporated by reference from the existing NAC's of the Nevada Transportation Authority.

14 5. The interests, welfare and convenience of the travelling public are served by the
15 Board's adoption of the Proposed Temporary Regulations.

16 6. Public policy favors approval and adoption of these Proposed Temporary Regulations
17 and the incorporation by reference of those certain existing NAC sections of the Nevada
18 Transportation Authority.

19 7. The Board's adoption of Proposed Temporary Rules is a reasonable and permissible
20 exercise of its authority to regulate the taxicab industry.

21 8. If any of the foregoing conclusions of law is more appropriately construed as a finding
22 of fact, it may be so construed.
