## **ORDER**

The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

- 1. On the 10th day of February, 2011, a public hearing was held regarding the above-entitled matter (the "Event"), in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties appeared and were heard.
- 2. The Taxicab Authority is authorized to allocate temporary additional medallions, pursuant to NRS 706.8824 and 706.88245, whenever circumstances require a temporary increase in the number of taxicabs allocated.
- 3. Staff recommended the allocation of temporary, special-event medallions for the above-referenced Event, based upon the estimated attendance, and the nature of the attendees and the events.

- 4. The following filed Petitions to Intervene and all were permitted to intervene and be heard: (1) Yellow/Checker/Star Cab Companies, (2) Nellis Cab Company, (3) Whittlesea Blue/Henderson Taxi, (4) Desert Cab Company, (5) Lucky Cab Company, (6) A Cab, LLC, (7) Western Cab Company, (8) Frias Holding Company, (9) United Steelworkers Union, and (10) ITPE Union.
- 5. Based upon the testimony and recommendations of staff and the Intervenors, the Board finds that there is a need for temporary, additional taxicabs to service the public at the Events, which the Board, accordingly, finds should be addressed by a temporary allocation of additional medallions.
- 6. Pursuant to NRS 706.88245(2), the Board is required to allocate the temporary increase in medallions equally among the certificate holders. All companies, except those specifically prohibited by their certificates, are entitled to share in the temporary additional allocation, which temporary additional medallions are only to be used in each company's certificated area.

THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary additional medallions to address the need for additional taxicabs for the above-referenced events, as follows:

2 medallions per company 7:00 A.M. to 7:00 P.M. and 2 medallions per company 12:00 P.M. to 2:00 A.M. (any 12-hour period)

## **FRIDAY, MARCH 18, 2011**

2 medallions per company 7:00 A.M. to 7:00 P.M. and 2 medallions per company 12:00 P.M. to 2:00 A.M. (any 12-hour period)
