18 The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact
19 and conclusions of law.

20 1. On the 5th day of April, 2011, a public hearing was held regarding the above-
21 entitled matter (the "Event"), in compliance with the provisions of the Nevada Open Meeting
22 Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes
23 (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties
24 appeared and were heard.

25 2. The Taxicab Authority is authorized to allocate temporary additional medallions,
26 pursuant to NRS 706.8824 and 706.88245, whenever circumstances require a temporary
27 increase in the number of taxicabs allocated.

28 3. Staff recommended the allocation of temporary, special-event medallions for the
above-referenced Event, based upon the estimated attendance, and the nature of the
attendees and the events.

1 4. The following filed Petitions to Intervene and all were permitted to intervene and
2 be heard: (1) Desert Cab Company, (2) Frias Holding Company, (3) A Cab, LLC, and (4)
3 Lucky Cab Company.

4 5. Based upon the testimony and recommendations of staff and the Interveners,
5 the Board finds that there is a need for temporary, additional taxicabs to service the public at
6 the Events, which the Board, accordingly, finds should be addressed by a temporary
7 allocation of additional medallions.

8 6. Pursuant to NRS 706.88245(2), the area to be affected by this order is the
9 Laughlin, Nevada area. The additional medallions must be used in the Laughlin, Nevada area
10 only.

11 THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary
12 additional medallions to address the need for additional taxicabs for the above-referenced
13 events, as follows:

14 2 medallions per company
Beginning 12:00 P.M. on Wednesday April 27, 2011
15 and continuing through 12:00 P.M. on Sunday May 1, 2011.

16 IT IS FURTHER ORDERED that the authorized additional cabs may be put into service
17 only during the times and dates and in the geographic area set forth herein.
