21 The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact
22 and conclusions of law.

23 1. On the 26th day of July, 2011, a public hearing was held regarding the above-
24 entitled matter (the “Event”), in compliance with the provisions of the Nevada Open Meeting
25 Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes
26 (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties
27 appeared and were heard.

28 2. The Taxicab Authority is authorized to allocate temporary additional medallions,
pursuant to NRS 706.8824 and 706.88245, whenever circumstances require a temporary
increase in the number of taxicabs allocated.

3. Applicants Frias Companies requested allocations of temporary medallions on
Sunday August 21, 2011, Monday August 22, 2011, Tuesday August 23, 2011, and

1 Wednesday August 24, 2011 based upon the nature of the event and the estimated number of
2 attendees.

3 3. The following filed Petitions to Intervene and all were permitted to intervene and
4 be heard: (1) Desert Cab Company, (2) A Cab, LLC, (3) Nellis Cab Company, (4) Whittlesea
5 Blue/Henderson Taxi, (6) Yellow/Checker/Star Cab Companies, (7) ITPE Union, and (8) Lucky
6 Cab Company. No representative of Western Cab or Nellis Cab were present.

7 5. Based upon the testimony and recommendations of the Applicants and
8 Intervenors, the Board finds that there is a need for temporary, additional taxicabs to service
9 the public at the Events, which the Board, accordingly, finds should be addressed by a
10 temporary allocation of additional medallions.

11 6. Pursuant to NRS 706.88245(2), the Board is required to allocate the temporary
12 increase in medallions equally among the certificate holders. All companies, except those
13 specifically prohibited by their certificates, are entitled to share in the temporary additional
14 allocation, which temporary additional medallions are only to be used in each company's
15 certificated area.

16 THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary
17 additional medallions to address the need for additional taxicabs for the above-referenced
18 events, as follows:

19 **SUNDAY, AUGUST 21, 2011**

20 6 medallions per company
12:00 P.M. to 2:00 A.M.
(any 12-hour period)

22 **MONDAY, AUGUST 22, 2011**

23 5 medallions per company
6:00 A.M. to 7:00 P.M.
(any 2-hour period)

24 *and*

25 6 medallions per company
12:00 P.M. to 2:00 A.M.
(any 12-hour period)

TUESDAY, AUGUST 23, 2011

5 medallions per company
6:00 A.M. to 7:00 P.M.
(any 12-hour period)

and

6 medallions per company
12:00 P.M. to 2:00 A.M.
(any 12-hour period)

WEDNESDAY, AUGUST 24, 2011

5 medallions per company
6:00 A.M. to 7:00 P.M.
(any 12-hour period)

and

6 medallions per company
12:00 P.M. to 2:00 A.M.
(any 12-hour period)

IT IS FURTHER ORDERED that the authorized additional taxicabs may be put into service only during the times and dates set forth herein.
