**ORDER**

The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

1. On the 29th day of November, 2011, a public hearing was held regarding the above-entitled matters (the "Events"), in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties appeared and were heard.

2. The Taxicab Authority is authorized to allocate temporary additional medallions, pursuant to NRS 706.88245, whenever circumstances require a temporary increase in the number of taxicabs allocated, pursuant to NRS 706.8824.

3. The Events run from January 9, 2012 to January 13, 2012.

4. The following filed Petitions to Intervene and all were permitted to intervene and be heard: (1) Desert Cab Company, (2) United Steelworkers Union, (3) Ace Cab, Inc./Union

1 Cab Co./ A NLV Cab Co./ Vegas-Western Cab Inc. /Virgin Valley Cab Company, Inc., (4)  
2 Nellis Cab Company, (5) Whittlesea Blue/Henderson Taxi, (6) Yellow/Checker/Star Cab  
3 Company, (7) Western Cab Company, (8) A Cab, LLC, (9) Lucky Cab Company, and (10)  
4 ITPE Union.

5 5. Based upon the testimony presented to the Board, the Board finds that there is a  
6 need for temporary, additional taxicabs to service the public at the Events which the Board,  
7 accordingly, finds should be addressed by a temporary allocation of additional medallions.

8 6. Pursuant to NRS 706.88245(2), the Board is required to allocate the temporary  
9 increase in medallions equally among the certificate holders. All companies are entitled to  
10 share in the temporary additional allocation, which temporary additional medallions are only to  
11 be used in each company's certificated area.

12 THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary  
13 additional medallions to address the need for additional taxicabs for the above-referenced  
14 events, as follows:

15 **MONDAY, JANUARY 9, 2012**

16 17 medallions per company  
17 12:00 PM to 2:00 AM  
(any 12 hour period)

18 **TUESDAY, JANUARY 10, 2012**

19 17 medallions per company  
20 7:00 AM to 7:00 PM  
*and*

21 17 medallions per company  
22 12:00 PM to 2:00 AM  
(any 12 hour period)

23 **WEDNESDAY, JANUARY 11, 2012**

24 17 medallions per company  
25 7:00 AM to 7:00 PM  
*and*

26 17 medallions per company  
27 12:00 PM to 2:00 AM  
(any 12 hour period)

28 **THURSDAY, JANUARY 12, 2012**

17 medallions per company  
7:00 AM to 7:00 PM

1 IT IS FURTHER ORDERED that the authorized additional cabs may be put into service  
2 only during the times and dates set forth herein.
