The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

- 1. On the 28th day of February, 2012, a public hearing was held regarding the above-entitled matter (the "Event"), in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties appeared and were heard.
- 2. The Taxicab Authority is authorized to allocate temporary additional medallions, pursuant to NRS 706.8824 and 706.88245, whenever circumstances require a temporary increase in the number of taxicabs allocated.
- 3. Staff recommended allocation of a limited number of temporary, special-event medallions for the above-referenced Event for Sunday March 11, 2012 only, based upon the estimated attendance, and the nature of the attendees and the events and the existing allocation of taxicabs.
- 4. The following filed Petitions to Intervene and all were permitted to intervene and be heard: (1) Yellow/Checker/Star Cab Companies, (2) Desert Cab Company, (3) Ace Cab,

Inc./Union Cab Co./ A NLV Cab Co./ Vegas-Western Cab Inc. /Virgin Valley Cab Company, Inc, (4) Nellis Cab Company, (5) United Steelworkers Union, (6) Lucky Cab Company, (7) A Cab, LLC, (8) Western Cab Company, (9) Whittlesea Blue/Henderson Taxi, and (10) ITPE Union.

- 5. Based upon staff's recommendations, as well as the testimony and recommendations of the Intervenors, the Board finds that there is a need for temporary, additional taxicabs to service the public at the Events on Sunday March 11, 2012, which the Board, accordingly, finds should be addressed by a temporary allocation of additional medallions.
- 6. Pursuant to NRS 706.88245(2), the Board is required to allocate the temporary increase in medallions equally among the certificate holders. All companies are entitled to share in the temporary additional allocation, which temporary additional medallions are only to be used in each company's certificated area.

THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary additional medallions to address the need for additional taxicabs for the above-referenced events, as follows:

SUNDAY, MARCH 11, 2012

3 medallions per company 7:00 A.M. to 2:00 A.M. (any 12 hour period)

IT IS FURTHER ORDERED that the authorized additional taxicabs may be put into service only during the times and dates set forth herein.
