16	The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and

19	1. On December 11, 2012, a public hearing was held regarding the above-entitled matter

21	Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes	
22	(NRS) and the Nevada Administrative Code (NAC), at which time all interested parties	
23	appeared and were permitted to be heard.

2. The Taxicab Authority is authorized to allocate temporary additional medallions,

pursuant to NRS 706.88245, whenever circumstances require a temporary increase in

- 3. The Event is the International CES Show at the LVCVA on January 8, 2013 through Friday, January 11, 2013, with an anticipated attendance of 155,000.
- 4. The following filed Petitions to Intervene and all were permitted to intervene and be heard: (1) Nellis Cab Company, (2) Yellow/Checker/Star Cab Companies, (3) Desert Cab Company, (4) Whittlesea Blue/Henderson Taxi, (5) Ace Cab, Inc./ Union Cab Co./ A NLV Cab Co./ Vegas-Western Cab, Inc./ Virgin Valley Cab Company, (6) Lucky Cab Company, (7) A Cab, LLC, and (8) ITPE Union.
- Intervenors were allowed to present argument and evidence regarding the nature of the event, the expected attendance of the event and the nature of the attendees of the event.
- 6. Based upon the arguments, evidence and recommendations submitted by Intervenors, the Board finds that there is a need for temporary, additional taxicabs to service the public at the Event, which the Board, accordingly, finds should be addressed by a temporary allocation of additional medallions.
- 7. Pursuant to NRS 706.88245(2), any temporary allocation of additional medallions must be apportioned equally among the certificate holders in the area to be affected by the allocation.

THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary additional medallions to address the need for additional taxicabs for the above-referenced event, as follows:
