**ORDER**

At a regular monthly session of the State of Nevada Taxicab Authority Board, held at the Nevada Taxicab Authority, 1785 E. Sahara Ave., Ste. 200, Las Vegas, NV 89104.

The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

1. On November 15, 2013, a public hearing was held regarding the above-entitled matter (the "Event"), in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties appeared and were permitted to be heard.
2. The Taxicab Authority is authorized to allocate temporary additional medallions, pursuant to NRS 706.88245, whenever circumstances require a temporary increase in the number of taxicabs allocated, pursuant to NRS 706.8824.
3. The Event is New Year's Eve, which falls on a Tuesday and has anticipated attendance of roughly 300,000.

1 4. The following filed Petitions to Intervene and all were permitted to intervene and be  
2 heard: (1) A Cab, LLC; (2) Sun Cab Inc. d/b/a Nellis Cab Company; (3) Desert Cab  
3 Company; (4) Yellow/Checker/Star Cab Companies; (5) Whittlesea Blue/Henderson  
4 Taxi; (6) Ace Cab, Inc., Union Cab Co., A NLV Cab Co, Vegas-Western Cab, Inc., and  
5 Virgin Valley Cab Company, Inc.; (7) Lucky Cab Company; (8) Western Cab Company;  
6 (9) ITPE Union.

7 5. Intervenors were allowed to present arguments and evidence regarding the nature of  
8 the event, the expected attendance of the event and the nature of the attendees of the  
9 event.

11 6. Based upon the arguments, evidence and recommendations submitted by Intervenors  
12 and staff, the Board finds that there is a need for temporary, additional taxicabs to  
13 service the public at the event, which the Board, accordingly, finds should be  
14 addressed by a temporary allocation of additional medallions.

15 7. Pursuant to NRS 706.88245(2), any temporary allocation of additional medallions must  
16 be apportioned equally among the certificate holders in the area to be affected by the  
17 allocation.

19 THEREFORE, IT IS HEREBY ORDERED that the Administrator shall issue temporary  
20 additional medallions to address the need for additional taxicabs for the above-referenced  
21 event, as follows:


